AN ACT to amend the penal law, in relation to designating promoting prostitution in the first degree, compelling prostitution and sex trafficking as class B violent felony offenses and the prostitution of minors

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (a) of subdivision 1 of section 70.02 of the penal law, as amended by chapter 320 of the laws of 2006, is amended to read as follows:

Class B violent felony offenses: an attempt to commit the class 5 A-I felonies of murder in the second degree as defined in section 125.25, kidnapping in the first degree as defined in section 135.25, and 7 arson in the first degree as defined in section 150.20; manslaughter in the first degree as defined in section 125.20, aggravated manslaughter 8 9 the first degree as defined in section 125.22, rape in the first degree as defined in section 130.35, criminal sexual act in the first 10 degree as defined in section 130.50, aggravated sexual abuse in the 11 12 first degree as defined in section 130.70, course of sexual conduct 13 against a child in the first degree as defined in section 130.75; 14 assault in the first degree as defined in section 120.10, kidnapping in second degree as defined in section 135.20, burglary in the first 15 degree as defined in section 140.30, arson in the second degree as 16 17 defined in section 150.15, robbery in the first degree as defined in 18 section 160.15, PROMOTING PROSTITUTION IN THE FIRST DEGREE AS DEFINED IN 19 SECTION 230.32, COMPELLING PROSTITUTION AS DEFINED IN SECTION 230.33, 20 SEX TRAFFICKING AS DEFINED IN SECTION 230.34, incest in the first degree defined in section 255.27, criminal possession of a weapon in the 21 first degree as defined in section 265.04, criminal use of a firearm in 22 23 first degree as defined in section 265.09, criminal sale of a firearm in the first degree as defined in section 265.13, aggravated 25 assault upon a police officer or a peace officer as defined in section 26 120.11, gang assault in the first degree as defined in section 120.07,

intimidating a victim or witness in the first degree as defined in section 215.17, hindering prosecution of terrorism in the first degree defined in section 490.35, criminal possession of a chemical weapon biological weapon in the second degree as defined in section 490.40, and criminal use of a chemical weapon or biological weapon in the third degree as defined in section 490.47.

- S 2. Section 230.30 of the penal law, as amended by chapter 627 of the laws of 1978, is amended to read as follows:
- 9 S 230.30 Promoting prostitution in the second degree.
- 10 A person is guilty of promoting prostitution in the second degree when he OR SHE knowingly[: 11
 - Advances] ADVANCES prostitution by compelling a person by force or intimidation to engage in prostitution, or profits from such coercive conduct by another[; or
- 15 2. Advances or profits from prostitution of a person less than sixteen years old]. 16 17
 - Promoting prostitution in the second degree is a class C felony.
- Section 230.32 of the penal law, as added by chapter 627 of the 18 19 laws of 1978, is amended to read as follows:
- S 230.32 Promoting prostitution in the first degree. 20
- 21 A person is guilty of promoting prostitution in the first degree when 22 he OR SHE knowingly advances or profits from prostitution of a person less than [eleven] SIXTEEN years old. 23
- 24 Promoting prostitution in the first degree is a class B felony.
- 25 S 4. This act shall take effect on the first of November next succeed-26 ing the date on which it shall have become a law and shall apply to offenses committed on or after such date. 27
