AN ACT to amend the administrative code of the city of New York, in
relation to terminal leave

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The administrative code of the city of New York is amended
2 by adding a new section 14-154 to read as follows:
3 S 14-154 TERMINAL LEAVE. NOTWITHSTANDING THE PROVISIONS OF ANY GENER-
4 AL, SPECIAL OR LOCAL LAW, CODE, RESOLUTION OR CHARTER TO THE CONTRARY,
5 MEMBERS OF THE NEW YORK CITY POLICE FORCE SHALL BE AFFORDED THE OPTION
6 OF TAKING A MONETARY PAYMENT OF UP TO FIFTY PERCENT OF ACCRUED TERMINAL
7 LEAVE AT THE RATE APPLICABLE ON THE DATE OF RETIREMENT. FURTHERMORE, ON
8 REACHING THEIR TWENTIETH ANNIVERSARY, MEMBERS OF THE NEW YORK CITY
9 POLICE DEPARTMENT SHALL HAVE THE OPTION OF UTILIZING TERMINAL LEAVE AS
10 TIME OWED TO THE MEMBER.
11 S 2. The administrative code of the city of New York is amended by
12 adding a new section 15-129 to read as follows:
13 S 15-129 TERMINAL LEAVE. NOTWITHSTANDING THE PROVISIONS OF ANY GENER-
14 AL, SPECIAL OR LOCAL LAW, CODE, RESOLUTION OR CHARTER TO THE CONTRARY,
15 MEMBERS OF THE NEW YORK CITY FIRE DEPARTMENT SHALL BE AFFORDED THE
16 OPTION OF TAKING A MONETARY PAYMENT OF UP TO FIFTY PERCENT OF ACCRUED
17 TERMINAL LEAVE AT THE RATE APPLICABLE ON THE DATE OF RETIREMENT.
18 FURTHERMORE, ON REACHING THEIR TWENTIETH ANNIVERSARY, MEMBERS OF THE NEW
19 YORK CITY FIRE DEPARTMENT SHALL HAVE THE OPTION OF UTILIZING TERMINAL
20 LEAVE AS TIME OWED TO THE MEMBER.
21 S 3. This act shall take effect immediately.
