- AN ACT to amend the public service law, in relation to the imposition of the temporary state energy and utility service conservation assessment

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (a) of subdivision 6 of section 18-a of the 2 public service law, as added by section 4 of part NN of chapter 59 of 3 the laws of 2009, is amended to read as follows:

(a) Notwithstanding any provision of law to the contrary, and subject 4 5 to the exceptions provided for in paragraph (b) of this subdivision, for the state fiscal year beginning on April first, two thousand nine and UP 6 7 state fiscal years thereafter, a temporary annual assessment TO four 8 (hereinafter "temporary state energy and utility service conservation 9 assessment") is hereby imposed on public utility companies (including for the purposes of this subdivision municipalities other than munici-10 palities as defined in section eighty-nine-1 of this chapter), corpo-11 rations (including for purposes of this subdivision the Long Island 12 power authority), and persons subject to the commission's regulation (hereinafter such public utility companies, corporations, and persons 13 14 are referred to collectively as the "utility entities") to encourage the 15 conservation of energy and other resources provided through utility 16 17 entities, to be assessed in the manner provided in this subdivision; 18 provided, however, that such assessment shall not be imposed upon telephone corporations as defined in subdivision seventeen of section two of 19 this article; AND PROVIDED, FURTHER, THAT THE AUTHORITY TO 20 IMPOSE SUCH ASSESSMENT SHALL EXPIRE AT THE END OF EACH STATE FISCAL YEAR ON OR AFTER 21 22 THIRTY-FIRST, TWO THOUSAND ELEVEN, UNLESS THE GOVERNOR REQUESTS MARCH 23 THE AUTHORITY FROM THE LEGISLATURE TO CONTINUE TO IMPOSE THE TEMPORARY 24 AND UTILITY SERVICE CONSERVATION ASSESSMENT FOR AN ADDI-STATE ENERGY
