AN ACT to amend the insurance law, in relation to coverage for the care of Alzheimer's and related disease patients

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is
2 amended by adding a new paragraph 28 to read as follows:

3 (28) (A) EVERY POLICY WHICH PROVIDES FOR SURGICAL OR MEDICAL COVERAGE
4 OR IN-PATIENT HOSPITAL CARE AS WELL AS NON-HEALTH RELATED SERVICES,
5 SHALL MAKE AVAILABLE, WHEN REQUESTED BY THE CONTRACT HOLDER, COVERAGE
6 FOR OUT-PATIENT TREATMENT OF ALZHEIMER'S OR RELATED DISEASES.

7 (B) FOR THE PURPOSES OF THIS PARAGRAPH, THE FOLLOWING TERMS SHALL HAVE
8 THE FOLLOWING MEANINGS:

9 (I) "NON-HEALTH RELATED SERVICES" MEANS THOSE OUT-PATIENT SERVICES
10 WHICH MEET THE CARE AND BEHAVIORAL NEEDS OF THE PATIENT, INCLUDING BUT
11 NOT LIMITED TO CRISIS INTERVENTION, ADULT DAY CARE, HOME CARE AND
12 RESPITE CARE.

13 (II) "CARE AND BEHAVIORAL NEEDS OF THE PATIENT" MEANS THE MANIFESTA-
14 TION OF SYMPTOMS WHICH MAY INCLUDE BUT NOT LIMITED TO MEMORY LOSS, APHA-
15 SIA (COMMUNICATION DISORDER), BECOMING LOST OR DISORIENTED, CONFUSION
16 AND AGITATION WITH THE POTENTIAL FOR COMBATIVENESS AND INCONTINENCE.

17 (III) "ALZHEIMER'S OR RELATED DISEASES" MEANS ANY OF THOSE IRREVERS-
18 IBLE BRAIN DISORDERS WHICH RESULT IN THE SYMPTOMS DESCRIBED IN THIS
19 PARAGRAPH BUT NOT LIMITED TO MULTI-INFARCT DEMENTIAS AND PARKINSON'S
20 DISEASE.

21 S 2. Subsection (l) of section 3221 of the insurance law is amended by
22 adding a new paragraph 18 to read as follows:

23 (18) (A) EVERY INSURER DELIVERING A GROUP POLICY OR ISSUING A GROUP
24 POLICY FOR DELIVERY IN THIS STATE WHICH PROVIDES HOSPITAL, SURGICAL OR
25 MEDICAL COVERAGE SHALL, IF REQUESTED BY THE POLICYHOLDER INCLUDE COVER-

1 AGE FOR THE TREATMENT AND DIAGNOSIS OF ALZHEIMER'S OR RELATED DISEASES.
2 SUCH COVERAGE FOR THE DIAGNOSIS AND TREATMENT SHALL INCLUDE HOSPITAL,
3 SURGICAL OR MEDICAL CARE TO THE SAME EXTENT THAT COVERAGE IS PROVIDED
4 FOR ILLNESS OR DISEASE UNDER THE POLICY.

5 (B) COVERAGE SHALL ALSO INCLUDE NON-HEALTH RELATED SERVICES AS WELL AS
6 BUT NOT LIMITED TO NURSING HOME CARE, LICENSED REGISTERED PROFESSIONAL
7 NURSE, PSYCHIATRISTS OR PSYCHOLOGISTS LICENSED TO PRACTICE IN THIS
8 STATE, HOME HEALTH SERVICES AND ANY OTHER MEDICAL AND REHABILITATIVE
9 TREATMENT.

10 (C) SUCH COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND COINSURANCE
11 AS MAY BE DEEMED APPROPRIATE BY THE SUPERINTENDENT. SUCH DEDUCTIBLES
12 AND COINSURANCE MAY BE CONSISTENT WITH THOSE IMPOSED ON OTHER BENEFITS
13 WITHIN A GIVEN POLICY.

14 (D) FOR THE PURPOSES OF THIS PARAGRAPH, THE FOLLOWING TERMS SHALL HAVE
15 THE FOLLOWING MEANINGS:

16 (I) "NON-HEALTH RELATED SERVICES" MEANS THOSE OUT-PATIENT SERVICES
17 WHICH MEET THE CARE AND BEHAVIORAL NEEDS OF THE PATIENT, INCLUDING BUT
18 NOT LIMITED TO CRISIS INTERVENTION, ADULT DAY CARE, HOME CARE AND
19 RESPITE CARE.

28 S 3. Paragraph 1 of subsection (d) of section 4301 of the insurance
29 law is amended to read as follows:

30 (1) (A) Hospital service shall consist of in-patient hospital care and
31 out-patient hospital care when such hospital care is provided through a
32 hospital which is maintained by the state or any of its political subdi-
33 visions, or maintained by a corporation organized for hospital purposes
34 under the laws of this state, or such other hospitals as shall be desig-
35 nated by the state department of health, and hospitals of other states
36 subject to the supervision of such other state, convalescent care
37 provided by any convalescent institution, or nursing care provided by
38 any nursing home.

39 (B) OUT-PATIENT HOSPITAL CARE SHALL INCLUDE, TO THE SAME EXTENT AS IS
40 PROVIDED FOR ILLNESS OR DISEASE UNDER THE POLICY, THE TREATMENT AND
41 DIAGNOSIS OF ALZHEIMER'S OR RELATED DISEASES AND NON-HEALTH RELATED
42 SERVICES.

43 (C) FOR THE PURPOSES OF THIS PARAGRAPH THE FOLLOWING TERMS SHALL HAVE
44 THE FOLLOWING MEANINGS:

45 (I) "NON-HEALTH RELATED SERVICES" MEANS THOSE OUT-PATIENT SERVICES
46 WHICH MEET THE CARE AND BEHAVIORAL NEEDS OF THE PATIENT, INCLUDING BUT

1 S 4. Paragraph 2 of subsection (e) and paragraph 2 of subsection (f)
2 of section 4303 of the insurance law, paragraph 2 of subsection (e) as
3 amended by chapter 593 of the laws of 2000, are amended to read as
4 follows:

5 (2) For the purpose of this subsection, ambulatory care in hospital
6 out-patient facilities shall mean [services]: (A) SERVICES for diagnos-
7 tic x-rays, laboratory and pathological examinations, physical and occu-
8 pational therapy and radiation therapy, and services and medications
9 used for nonexperimental cancer chemotherapy and cancer hormone therapy,
10 provided that such services and medications are (i) related to and
11 necessary for the treatment or diagnosis of the patient's illness or
12 injury, (ii) ordered by a physician and (iii) in the case of physical
13 therapy, services are to be furnished in connection with the same
14 illness for which the patient had been hospitalized or in connection
15 with surgical care, but in no event need benefits for physical therapy
16 be provided which commences more than six months after discharge from a
17 hospital or the date surgical care was rendered, and in no event need
18 benefits for physical therapy be provided after three hundred sixty-five
19 days from the date of discharge from a hospital or the date surgical
20 care was rendered. Such coverage shall be made available at the incep-
21 tion of all new contracts and, with respect to all other contracts, at
22 any anniversary date subject to evidence of insurability.

23 (B) TREATMENT AND DIAGNOSIS OF ALZHEIMER'S OR RELATED DISEASES AND

25 (C) FOR THE PURPOSES OF THIS PARAGRAPH, THE FOLLOWING TERMS SHALL HAVE

27 (I) "NON-HEALTH RELATED SERVICES" MEANS THOSE OUT-PATIENT SERVICES

39 (2) For the purpose of this subsection, ambulatory care in physi-
40 cians' offices shall mean [services]: (A) SERVICES for diagnostic
41 x-rays, radiation therapy, laboratory and pathological examinations, and
42 services and medications used for nonexperimental cancer chemotherapy
43 and cancer hormone therapy, provided that such services and medications
44 are (i) related to and necessary for the treatment or diagnosis of the
45 patient's illness or injury, and (ii) ordered by a physician. Such
46 coverage shall be made available at the inception of all new contracts
47 and, with respect to all other contracts at any anniversary date subject
48 to evidence of insurability.

49 (B) TREATMENT AND DIAGNOSIS OF ALZHEIMER'S OR RELATED DISEASES AND
50 NON-HEALTH RELATED SERVICES.

51 (C) FOR THE PURPOSES OF THIS PARAGRAPH THE FOLLOWING TERMS SHALL HAVE
52 THE FOLLOWING MEANINGS:

53 (I) "NON-HEALTH RELATED SERVICES" MEANS THOSE OUT-PATIENT SERVICES

9 S 5. This act shall take effect on the one hundred twentieth day after
10 it shall have become a law, provided however, that effective immediate-
11 ly, the addition, amendment and/or repeal of any rules or regulations
12 necessary for the implementation of the provisions of this act on its
13 effective date are authorized and directed to be made and completed on
14 or before such effective date and shall apply to all policies and
15 contracts issued, renewed, modified, altered or amended on or after such
16 effective date.
