AN ACT to amend the labor law, in relation to reciprocity of debarments imposed under the federal Davis-Bacon Act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Paragraph b of subdivision 3 of section 220-b of the labor law is amended by adding a new subparagraph 3 to read as follows:
- (3) WHEN ANY PERSON OR ENTITY IS DEBARRED FOR HAVING DISREGARDED OBLI-GATIONS TO EMPLOYEES UNDER THE DAVIS-BACON ACT PURSUANT TO 40 U.S.C. 3144 AND 29 C.F.R. 5.12, SUCH PERSON OR ENTITY, AND ANY FIRM, RATION, PARTNERSHIP, OR ASSOCIATION IN WHICH THE PERSON OR ENTITY HAS AN 7 INTEREST, SHALL BE INELIGIBLE TO SUBMIT A BID ON OR BE AWARDED ANY PUBLIC WORKS CONTRACT WITH THE STATE, ANY MUNICIPAL CORPORATION, 8 BENEFIT CORPORATION OR PUBLIC BODY, FOR A PERIOD OF THREE YEARS FROM THE 9 DATE ON WHICH THE NAME OF THE PERSON OR ENTITY IS PUBLISHED IN THE LIST 10 OF DEBARRED CONTRACTORS PURSUANT TO 40 U.S.C. 3144. 11
- 12 S 2. This act shall take effect immediately.
