AN ACT to amend the real property tax law, in relation to the procedure for reviewing small claims in certain cases

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 730 of the real property tax law is amended by
2 adding a new subdivision 10 to read as follows:

3 10. (A) IN ANY CASE WHERE A PROPERTY OWNER SHALL HAVE FIRST FILED A
4 COMPLAINT PURSUANT TO SECTION FIVE HUNDRED TWENTY-FOUR OR SECTION FOUR-
5 TEEN HUNDRED EIGHT OF THIS CHAPTER OR THE PROVISIONS OF A LOCAL LAW OR
6 CHARTER PROVIDING FOR ADMINISTRATIVE REVIEW OF ASSESSMENTS, AND SUCH
7 OWNER HAS NOT RECEIVED NOTICE OF THE DETERMINATION WITH RESPECT THERETO
8 AT LEAST SEVEN BUSINESS DAYS PRIOR TO THE LAST DAY TO FILE THE PETITION
9 PROVIDED FOR IN SUBDIVISION THREE OF THIS SECTION, SUCH OWNER SHALL BE
10 ENTITLED TO COMMENCE A PROCEEDING PURSUANT TO THIS TITLE. IN ANY SUCH
11 CASE THE TWENTY-FIVE DOLLAR FEE PROVIDED FOR IN SUBDIVISION THREE OF
12 THIS SECTION SHALL BE REFUNDED.

13 (B) THE FORM UPON WHICH A COMPLAINT FILED BY A PROPERTY OWNER PURSUANT
14 TO SECTION FIVE HUNDRED TWENTY-FOUR OR SECTION FOURTEEN HUNDRED EIGHT OF
15 THIS CHAPTER OR THE PROVISIONS OF A LOCAL LAW OR CHARTER PROVIDING FOR
16 ADMINISTRATIVE REVIEW OF ASSESSMENTS, SHALL CONTAIN A BRIEF EXPLANATION
17 OF THE PETITION PROCEDURE PROVIDED FOR IN PARAGRAPH (A) OF THIS SUBDIVI-
18 SION.

19 S 2. This act shall take effect immediately and shall apply to
20 petitions filed against assessment rolls prepared on or after the first
21 of January next succeeding the date on which it shall have become a law.
