AN ACT to amend the administrative code of the city of New York, in relation to certification of payment of rent by the human resources administration to the tenant

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Title 26 of the administrative code of the city of New York  
2     is amended by adding a new chapter 10 to read as follows:

3                                   CHAPTER 10

4                   CERTIFICATION OF CERTAIN RENT PAYMENT

5     S 26-901 CERTIFICATION OF PAYMENT. (A) WHENEVER RENT IS PAID BY THE  
6     HUMAN RESOURCES ADMINISTRATION TO A LANDLORD ON BEHALF OF A TENANT WHO  
7     IS RECEIVING PUBLIC ASSISTANCE, THE HUMAN RESOURCES ADMINISTRATION SHALL  
8     ISSUE A CERTIFICATION OF PAYMENT TO SUCH TENANT, UPON REQUEST BY THE  
9     TENANT FOR CERTIFICATION. THE CERTIFICATION OF PAYMENT SHALL SET FORTH:

10       (1) THE DATE THE PAYMENT WAS MAILED;

11       (2) THE NAME OF THE LANDLORD TO WHOM THE PAYMENT WAS MAILED;

12       (3) THE ADDRESS TO WHICH PAYMENT WAS MAILED; AND

13       (4) THE AMOUNT OF PAYMENT MAILED.

14     (B) A REQUEST FOR CERTIFICATION OF PAYMENT MAY BE MADE BY THE TENANT  
15     IN PERSON AT THE TENANT'S ASSIGNED HUMAN RESOURCE ADMINISTRATION OFFICE  
16     OR BY THE TENANT OR THE LANDLORD BY TELEPHONE. IF A REQUEST IS MADE IN  
17     PERSON, THE CERTIFICATION OF PAYMENT SHALL BE MADE AVAILABLE TO THE  
18     TENANT AT THE TENANT'S ASSIGNED HUMAN RESOURCE ADMINISTRATION OFFICE NOT  
19     MORE THAN TWO DAYS AFTER THE REQUEST IS MADE. IF THE REQUEST IS MADE BY  
20     TELEPHONE, THE CERTIFICATION OF PAYMENT SHALL BE SENT VIA FIRST CLASS  
21     MAIL TO THE TENANT AT HIS OR HER LAST KNOWN ADDRESS NOT MORE THAN  
22     FIFTEEN DAYS AFTER THE REQUEST IS MADE. EACH HUMAN RESOURCE ADMINIS-

1 TRATION OFFICE SHALL DESIGNATE A TELEPHONE NUMBER FOR USE BY TENANTS AND  
2 LANDLORDS TO REQUEST CERTIFICATION OF PAYMENT.  
3 (C) AT THE TIME OF APPROVAL OF AN APPLICATION FOR PUBLIC ASSISTANCE,  
4 THE HUMAN RESOURCE ADMINISTRATION OFFICE SHALL PROVIDE THE APPLICANT FOR  
5 ASSISTANCE WITH WRITTEN NOTICE OF HIS OR HER RIGHT TO REQUEST AND  
6 RECEIVE CERTIFICATION OF RENT PAYMENTS AS PROVIDED IN THIS SECTION.  
7 S 2. This act shall take effect on the one hundred twentieth day after  
8 it shall have become a law; provided, however, that the human resources  
9 administration shall promulgate rules and regulations necessary to  
10 effectuate this act prior to such effective date.
