AN ACT to amend the vehicle and traffic law, in relation to establishing  
distinctive "Pink Ribbon" plates; and to amend the state finance law,  
in relation to establishing the "breast cancer education and support  
fund"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. The vehicle and traffic law is amended by adding a new  
2     section 404-x to read as follows:  
3     S 404-X. DISTINCTIVE "PINK RIBBON" LICENSE PLATES. 1. ANY PERSON  
4     RESIDING IN THIS STATE SHALL, UPON REQUEST, BE ISSUED A DISTINCTIVE  
5     "PINK RIBBON" LICENSE PLATE OF A DESIGN APPROVED BY THE COMMISSIONER.  
6     APPLICATION FOR SAID LICENSE PLATE SHALL BE FILED WITH THE FORM AND  
7     DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.  
8     2. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED  
9     IN THE SAME MANNER AS OTHER NUMBER PLATES UPON THE PAYMENT OF THE REGU-  
10    LAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS  
11    ARTICLE, PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF  
12    TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH ADDITIONAL  
13    SERVICE CHARGE SHALL BE DEPOSITED PURSUANT TO SECTION FOUR HUNDRED  
14    FOUR-OO OF THIS ARTICLE TO THE CREDIT OF THE DEPARTMENT OF MOTOR VEHI-  
15    CLES DISTINCTIVE PLATE DEVELOPMENT FUND, ESTABLISHED BY SECTION NINETY-  
16    FIVE-G OF THE STATE FINANCE LAW, AND SHALL BE USED FOR THE PRODUCTION,  
17    DESIGN, ADVERTISING AND MARKETING OF DISTINCTIVE NUMBER PLATES;  
18    PROVIDED, HOWEVER, THAT ADDITIONAL ANNUAL SERVICE CHARGES COLLECTED IN  
19    EXCESS OF SIX THOUSAND DOLLARS SHALL BE DEPOSITED TO THE CREDIT OF THE  
20    BREAST CANCER EDUCATION AND SUPPORT FUND ESTABLISHED PURSUANT TO SECTION  
21    NINETY-FIVE-H OF THE STATE FINANCE LAW.

1       S   2. The state finance law is amended by adding a new section 95-h to  
2 read as follows:  
3       S   95-H. BREAST CANCER EDUCATION AND SUPPORT FUND. 1. THERE IS HEREBY  
4 ESTABLISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF TAXATION AND  
5 FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS THE "BREAST  
6 CANCER EDUCATION AND SUPPORT FUND".  
7       2. SUCH FUND SHALL CONSIST OF ALL MONEYS COLLECTED PURSUANT TO SECTION  
8 FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW, AND ALL OTHER MONEYS  
9 APPROPRIATED, CREDITED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR  
10 SOURCE PURSUANT TO LAW.  
11       3. MONEYS OF THE FUND SHALL BE EXPENDED BY THE DEPARTMENT FOR BREAST  
12 CANCER EDUCATION AND SUPPORT PROJECTS AND GRANTS TO COMMUNITY-BASED  
13 ORGANIZATIONS PURSUANT TO SECTION TWENTY-FOUR HUNDRED SIX-A OF THE  
14 PUBLIC HEALTH LAW.  
15       S 3. This act shall take effect immediately.
