AN ACT to amend the penal law, in relation to grand larceny and unauthorized use of a vehicle and repealing subdivision 1 of section 165.05 of such law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 155.35 of the penal law, as amended by chapter 464
2 of the laws of 2010, is amended to read as follows:
3 S 155.35 Grand larceny in the third degree.
4 A person is guilty of grand larceny in the third degree when he or
5 she:
6 1. steals property and:
7 [1.] (A) when the value of the property exceeds three thousand
8 dollars, or
9 [2.] (B) the property is an automated teller machine or the contents
10 of an automated teller machine; OR
11 2. COMMITS THE CRIME OF GRAND LARCENY IN THE FOURTH DEGREE AS DEFINED
12 IN SUBDIVISION EIGHT OF SECTION 155.30 OF THIS ARTICLE AND HAS BEEN
13 PREVIOUSLY CONVICTED OF THE CRIME OF GRAND LARCENY IN THE FOURTH DEGREE
14 AS DEFINED IN SUCH SUBDIVISION.
15 Grand larceny in the third degree is a class D felony.
16 S 2. Subdivision 1 of section 165.05 of the penal law is REPEALED.
17 S 3. Section 165.06 of the penal law, as amended by chapter 413 of
18 the laws of 1982, is amended to read as follows:
19 S 165.06 Unauthorized use of a vehicle in the second degree.
20 A person is guilty of unauthorized use of a vehicle in the second
21 degree when:
22 He commits the crime of unauthorized use of a vehicle in the third
23 degree as defined in subdivision [one] TWO of section 165.05 of this
24 article and has been previously convicted of THIS SECTION OR the crime

6 S 4. This act shall take effect on the first of November next succeed-
7 ing the date on which it shall have become a law.
