AN ACT to amend the tax law, in relation to the disposition of revenue from the lottery prize account

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraphs 3 and 4 of subdivision a of section 1612 of the tax law, paragraph 3 as amended by section 2 of part D of chapter 383 of the laws of 2001 and paragraph 4 as amended by chapter 2 of the laws of 1995, are amended to read as follows:

- (3) [fifty] FORTY-FIVE percent of the total amount for which tickets have been sold for games known as: (A) the "Daily Numbers Game" or "Win 4", discrete games in which the participants select no more than three or four of their own numbers to match with three or four numbers drawn by the division for purposes of determining winners of such games, (B) "Pick 10", offered no more than once daily, in which participants select from a specified field of numbers a subset of ten numbers to match against a subset of numbers to be drawn by the division from such field of numbers for the purpose of determining winners of such game, (C) "Take 5", offered no more than once daily, in which participants select from a specified field of numbers a subset of five numbers to match against a subset of five numbers to be drawn by the division from such field of numbers for purposes of determining winners of such game, and (D) any joint, multi-jurisdiction, and out-of-state lottery; or
- (4) [forty] THIRTY-FIVE percent of the total amount for which tickets have been sold for: (A) "Lotto", offered no more than once daily, a discrete game in which all participants select a specific subset of numbers to match a specific subset of numbers, as prescribed by rules and regulations promulgated and adopted by the division, from a larger specific field of numbers, as also prescribed by such rules and requ-

lations and (B) with the exception of the game described in paragraph one of this subdivision, such other state-operated lottery games which the division may introduce, offered no more than once daily, commencing on or after forty-five days following the official publication of the rules and regulations for such game.

S 2. The opening paragraph of paragraph 1 of subdivision b of section 1612 of the tax law, as amended by section 1 of part O-1 of chapter 57 of the laws of 2009, is amended to read as follows:

Notwithstanding section one hundred twenty-one of the state finance 9 law, on or before the twentieth day of each month, the division shall 10 pay into the state treasury, to the credit of the state lottery fund 11 created by section ninety-two-c of the state finance law, not less than 12 [forty-five] FIFTY percent of the total amount for which tickets have 13 been sold for games defined in paragraph four of subdivision a of this 14 15 section during the preceding month, not less than thirty-five percent of the total amount for which tickets have been sold for games defined in 16 17 paragraph three of subdivision a of this section during the preceding month, not less than [twenty] FORTY percent of the total 18 amount for 19 which tickets have been sold for games defined in paragraph two of 20 subdivision a of this section during the preceding month, provided 21 however that for games with a prize payout of seventy-five percent of 22 the total amount for which tickets have been sold, the division shall pay not less than ten percent of sales into the state treasury and not 23 less than twenty-five percent of the total amount for which tickets have 24 25 been sold for games defined in paragraph one of subdivision a of this 26 section during the preceding month; and the balance of the total revenue after payout for prizes for games known as "video lottery gaming," (i) 27 less ten percent of the total revenue wagered after payout for prizes to 28 29 be retained by the division for operation, administration, and procurement purposes; (ii) less a vendor's fee the amount of which is to be 30 paid for serving as a lottery agent to the track operator of a vendor 31 32 track:

33 S 3. This act shall take effect on the first of October next succeed-34 ing the date on which it shall have become a law.
