AN ACT to amend the mental hygiene law, in relation to directing the commissioner of mental health to promulgate regulations providing for the segregation of sex offender patients from other patients

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The mental hygiene law is amended by adding a new section  
2     33.27 to read as follows:  
3     S 33.27 REQUIREMENT TO CHECK SEX OFFENDER REGISTRY; CONTINUING CLINICAL  
4         OUTPATIENT TREATMENT.  
5     THE COMMISSIONER OF MENTAL HEALTH SHALL PROMULGATE REGULATIONS  
6     PROSCRIBING, TO THE EXTENT PRACTICABLE, THE PROVISION OF CARE AND TREAT-  
7     MENT OF SEX OFFENDERS, AS DEFINED BY SECTION ONE HUNDRED SIXTY-EIGHT-A  
8     OF THE CORRECTION LAW, AND DETAINED SEX OFFENDERS, AS DEFINED BY SECTION  
9     10.03 OF THIS CHAPTER, BY FACILITIES AND PROGRAMS LICENSED OR OPERATED  
10    BY THE DEPARTMENT CONCURRENTLY AND IN THE SAME GROUP OF TWO OR MORE  
11    INDIVIDUALS AS PATIENTS OR CLIENTS WHO ARE NOT SEX OFFENDERS OR DETAINED  
12    SEX OFFENDERS. SUCH REGULATIONS SHALL ADDRESS ASPECTS INCLUDING, BUT NOT  
13    LIMITED TO: THE TYPES OF FACILITIES AND PROGRAMS SUBJECT TO RELEVANT  
14    PROVISIONS; PROTOCOLS FOR DETERMINING WHETHER A CLIENT OR PATIENT IS A  
15    SEX OFFENDER, AND CIRCUMSTANCES UNDER WHICH SUCH PROTOCOLS SHALL AND
