AN ACT to amend the general municipal law, in relation to authorizing reduced rates for water charged to laundry businesses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The general municipal law is amended by adding a new  
2     section 118-d to read as follows:  
3     S 118-D. LAUNDRIES; REDUCED WATER RATES. 1. FOR PURPOSES OF THIS  
4     SECTION, THE FOLLOWING TERMS SHALL HAVE THE FOLLOWING MEANINGS:  
5     A. "USE WATER EXCLUSIVELY" SHALL MEAN THE USE OF WATER FOR WHICH NOT  
6     LESS THAN NINETY PERCENT OF SUCH USE IS USED FOR THE PURPOSE OF OPERAT-  
7     ING A LAUNDRY;  
8     B. "LAUNDRY" SHALL MEAN A COIN-OPERATED LAUNDRY, DRY CLEANER OR ANY  
9     OTHER ENTITY THAT PROVIDES FOR THE LAUNDERING OF CLOTHES ON THE PREM-  
10    ISES;  
11    C. "MUNICIPALITY" SHALL MEAN A COUNTY, TOWN, CITY OR VILLAGE;  
12    D. "WATER AUTHORITY" SHALL MEAN ANY WATER AUTHORITY ESTABLISHED PURSU-  
13    ANT TO THE LAWS OF THIS STATE.  
14    2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ANY WATER AUTHORITY,  
15    MUNICIPALITY OR OTHER ENTITY WHICH SUPPLIES WATER TO CONSUMERS IN THIS  
16    STATE MAY, BY THE ADOPTION OF A RESOLUTION OR SIMILAR ACT, PROVIDE FOR A  
17    REDUCED RATE FOR WATER CHARGED TO BUSINESS CONSUMERS WHO USE WATER  
18    EXCLUSIVELY FOR THE PURPOSE OF OPERATING A LAUNDRY. SUCH REDUCTION IN  
19    WATER RATES SHALL NOT EXCEED FIFTEEN PERCENT OF THE STANDARD RATE CHARG-  
20    ES TO SUCH CONSUMERS.  
21    S 2. This act shall take effect immediately.
