AN ACT to amend the agriculture and markets law and the education in relation to authorizing school districts and institutions of higher education to donate excess food to local voluntary food assistance programs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. Section 16 of the agriculture and markets law is amended by 2 adding a new subdivision 5-c to read as follows:
  - 5-C. COOPERATE WITH THE COMMISSIONER OF EDUCATION, PURSUANT TO SUBDI-VISION THIRTY-TWO OF SECTION THREE HUNDRED FIVE OF THE EDUCATION LAW, TO DEVELOP GUIDELINES FOR THE VOLUNTARY IMPLEMENTATION BY SCHOOL DISTRICTS AND INSTITUTIONS OF HIGHER EDUCATION, AS DEFINED IN SUBDIVISION EIGHT OF SECTION TWO OF THE EDUCATION LAW, OF PROGRAMS WHICH ENCOURAGE THE DONATION OF EXCESS, UNUSED, EDIBLE FOOD FROM MEALS SERVED AT SUCH EDUCA-TIONAL FACILITIES TO LOCAL VOLUNTARY FOOD ASSISTANCE PROGRAMS.
- 10 S 2. Section 305 of the education law is amended by adding subdivision 32 to read as follows: 11
- 12 32. THE COMMISSIONER, IN CONSULTATION AND COOPERATION WITH THE COMMIS-SIONER OF AGRICULTURE AND MARKETS, SHALL DEVELOP VOLUNTARY GUIDELINES TO 13 ENCOURAGE AND FACILITATE THE ABILITY OF SCHOOL DISTRICTS AND INSTI-14 15 TUTIONS OF HIGHER EDUCATION TO DONATE EXCESS, UNUSED, EDIBLE FOOD FROM SERVED AT SUCH EDUCATIONAL FACILITIES TO LOCAL VOLUNTARY FOOD 16 MEALS 17 ASSISTANCE PROGRAMS INCLUDING, BUT NOT LIMITED TO, COMMUNITY FOOD SOUP KITCHENS, AND OTHER COMMUNITY AND NOT-FOR-PROFIT ORGAN-18
- IZATIONS THAT DISTRIBUTE FOOD TO THE POOR AND DISADVANTAGED. 19

- 21 A. A METHODOLOGY TO PROVIDE INFORMATION TO EDUCATIONAL INSTITUTIONS

B. A MEANS BY WHICH EDUCATIONAL INSTITUTIONS ARE PROVIDED WITH THE NAMES AND ADDRESSES OF ALL NEARBY LOCAL VOLUNTARY FOOD ASSISTANCE PROGRAMS;

- 4 C. A MEANS BY WHICH LOCAL VOLUNTARY FOOD ASSISTANCE PROGRAMS ARE 5 PROVIDED WITH THE NAMES AND ADDRESSES OF NEARBY EDUCATIONAL INSTITUTIONS 6 WHICH SERVE MEALS UPON THEIR PREMISES;

- 12 THE COMMISSIONER SHALL COORDINATE THE IMPLEMENTATION OF SUCH GUIDE-
- 13 LINES WITH THE FARM-TO-SCHOOL PROGRAM AND THE NEW YORK HARVEST FOR NEW
- 14 YORK KIDS WEEK PROGRAM ESTABLISHED PURSUANT TO SUBDIVISION FIVE-B OF
- 15 SECTION SIXTEEN OF THE AGRICULTURE AND MARKETS LAW.
- 16 S 3. This act shall take effect immediately.
