AN ACT to amend the executive law, in relation to the qualifications for members of the division of state police

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 3 of section 215 of the executive law, as amended by chapter 478 of the laws of 2004, is amended to read as follows:

The sworn members of the New York state police shall be appointed by the superintendent and permanent appointees may be removed by the 5 6 superintendent only after a hearing. No person shall be appointed to the 7 New York state police force as a sworn member unless he or she shall be 8 a citizen of the United States, [between the ages of] AT LEAST [and twenty-nine] years [except that 9 in the superintendent's 10 discretion, the maximum age may be extended to thirty-five years] OF [Notwithstanding any other provision of law or any general or 11 special law to the contrary the time spent on military duty, not exceeding a total of six years, shall be subtracted from the age of any appli-12 13 14 cant who has passed his or her twenty-ninth birthday, solely for 15 purpose of permitting qualification as to age and for no other purpose. Such limitations as to age however shall not apply to persons appointed 16 17 to the positions of counsel, first assistant counsel, assistant counsel, 18 assistant deputy superintendent for employee relations nor to any person appointed to the bureau of criminal investigation pursuant to 19 section two hundred sixteen of this article nor shall any] NO person 20 21 SHALL be appointed unless he or she has fitness and good moral character 22 and shall have passed a physical and mental examination based upon stan-23 dards provided by the rules and regulations of the superintendent. Appointments shall be made for a probationary period which, in the case

of appointees required to attend and complete a basic training program at the state police academy, shall include such time spent attending the 3 basic school and terminate one year after successful completion thereof. All other sworn members shall be subject to a probationary period of one 5 year from the date of appointment. Following satisfactory completion of 6 the probationary period the member shall be a permanent appointee. 7 Voluntary resignation or withdrawal from the New York state police 8 during such appointment shall be submitted to the superintendent for 9 Reasonable time shall be required to account for all equipapproval. 10 ment issued or for debts or obligations to the state to be satisfied. Resignation or withdrawal from the division during a time of emergency, 11 12 so declared by the governor, shall not be approved if contrary to the 13 best interest of the state and shall be a misdemeanor. No sworn member 14 removed from the New York state police shall be eligible for reappoint-15 The superintendent shall make rules and regulations subject to 16 approval by the governor for the discipline and control of the New York 17 state police and for the examination and qualifications of applicants 18 for appointment as members thereto and such examinations shall be held 19 and conducted by the superintendent subject to such rules and regulations. The superintendent is authorized to charge a fee of twenty 20 21 dollars as an application fee for any person applying to take a compet-22 itive examination for the position of trooper, and a fee of five dollars 23 for any competitive examination for a civilian position. The superintendent shall promulgate regulations subject to the approval of the direc-24 25 the budget, to provide for a waiver of the application fee when 26 the fee would cause an unreasonable hardship on the applicant and to establish a fee schedule and charge fees for the use of state police 27 28 facilities. THE SUPERINTENDENT SHALL REQUIRE THE RETIREMENT OF 29 MEMBER OF THENEW YORK STATE POLICE WHO HAS ATTAINED SEVENTY YEARS OF 30 AGE.

31 S 2. This act shall take effect immediately.
