AN ACT to amend the insurance law, in relation to collision or comprehensive coverage on motor vehicles

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 2610 of the insurance law is amended by adding a new subsection (c) to read as follows:

- (C)(1) NO INSURER IN PROCESSING ANY SUCH CLAIM, SHALL LIMIT THE PAYMENT OF SUCH CLAIM FOR DAMAGE TO A MOTOR VEHICLE REPAIR BASED ON PRICING CAPS FOR LABOR, PARTS, PAINT OR REPAIR MATERIALS. ALL ELEMENTS OF SUCH A CLAIM FOR DAMAGES SHALL BE NEGOTIATED WITH THE INSURED, OR HIS OR HER DESIGNATED REPRESENTATIVE, BY A DULY LICENSED APPRAISER.
- 8 (2) IF A RECOMMENDATION OR SUGGESTION OF AN AUTOMOTIVE REPAIR FACILITY 9 IS MADE BY THE INSURER, AND ACCEPTED BY THE CLAIMANT, THE INSURER SHALL DAMAGED VEHICLE TO BE RESTORED TO ITS CONDITION IMMEDIATELY 10 CAUSE THE PRIOR TO THE LOSS AT NO ADDITIONAL COST TO THE CLAIMANT 11 OTHER DEDUCTIONS STATED IN THE POLICY. SHOULD THE INSURER FAIL TO RESTORE THE 12 VEHICLE TO ITS CONDITION IMMEDIATELY PRIOR 13 TO THE LOSS, THE 14 SHALL AT NO ADDITIONAL EXPENSE TO THE CLAIMANT CAUSE THE VEHICLE TO BE RESTORED TO ITS CONDITION IMMEDIATELY PRIOR TO THE LOSS AT A SHOP OF THE 15 CLAIMANT'S CHOICE. THE INSURER SHALL MAINTAIN IN ITS FILE, A 16 STATEMENT, 17 THE CLAIMANT, PLAINLY PRINTED IN NO LESS THAN 10 POINT TYPE: "PURSUANT TO SECTION 2610 OF THE INSURANCE LAW, AN INSURANCE COMPANY MAY 18 19 NOT LIMIT PAYMENT BASED ON PRICING CAPS FOR LABOR, PARTS, PAINT 20 MATERIALS. AN INSURER CANNOT REQUIRE THAT REPAIRS BE MADE TO A MOTOR VEHICLE IN A PARTICULAR PLACE OR REPAIR SHOP. YOU HAVE 21 THE RIGHT TO HAVE YOUR VEHICLE REPAIRED IN THE SHOP OF YOUR CHOICE". 22
- 23 S 2. This act shall take effect on the first of January next succeed-24 ing the date on which it shall have become a law and shall apply to all 25 policies and contracts issued, renewed, modified, altered or amended on

or after such effective date; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
