AN ACT to amend the public authorities law and the New York state urban development corporation act, in relation to requiring organizations that receive funds for capital improvements by the New York state dormitory authority and the upstate empire state development corporation to use such funds for the purchase of energy star equipment and appliances where available

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public authorities law is amended by adding a new
2 section 1680-q to read as follows:
3 S 1680-Q. CAPITAL IMPROVEMENT FUNDING. 1. ANY FUNDS ADMINISTERED OR
4 APPROPRIATED BY THE DORMITORY AUTHORITY TO AN ORGANIZATION FOR THE
5 PURPOSES OF BUILDING UPGRADES, APPLIANCE PURCHASES, OR OTHER CAPITAL
6 IMPROVEMENTS, SHALL BE USED TO PURCHASE ONLY ENERGY STAR EQUIPMENT AND
7 APPLIANCES, WHERE AVAILABLE.
8 2. FOR THE PURPOSES OF THIS SECTION, THE TERM "ENERGY STAR" SHALL MEAN
9 A DESIGNATION FROM THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY OR
10 DEPARTMENT OF ENERGY INDICATING THAT A PRODUCT MEETS THE ENERGY EFFI-
11 CIENCY STANDARDS SET FORTH BY THE AGENCY FOR COMPLIANCE WITH THE ENERGY
12 STAR PROGRAM.
13 S 2. Section 1 of chapter 174 of the laws of 1968, constituting the
14 New York state urban development corporation act, is amended by adding a
15 new section 16-v to read as follows:
16 S 16-V. CAPITAL IMPROVEMENT FUNDING. 1. ANY FUNDS ADMINISTERED OR
17 APPROPRIATED BY THE UPSTATE EMPIRE STATE DEVELOPMENT CORPORATION TO AN

1 ORGANIZATION FOR THE PURPOSES OF BUILDING UPGRADES, APPLIANCE PURCHASES,

9 S 3. This act shall take effect immediately.
