AN ACT to amend the election law, in relation to voter pre-registration

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Paragraph o of subdivision 4 of section 5-500 of the election law, as amended by chapter 659 of the laws of 1994, is amended and a new paragraph p is added to read as follows:
 - o. A space for "remarks" regarding other facts required by this chapter to be recorded or appropriate to identify the voter[.];

- P. A SPACE FOR PRE-REGISTERING APPLICANTS TO RESPOND TO THE FOLLOWING QUESTION: "ARE YOU AT LEAST 16 YEARS OF AGE AND UNDERSTAND THAT YOU MUST BE 18 YEARS OF AGE ON OR BEFORE ELECTION DAY TO VOTE, AND THAT UNTIL YOU REACH THE AGE OF 18 YOUR REGISTRATION WILL BE MARKED AS 'PENDING' AND YOU WILL BE UNABLE TO CAST A BALLOT IN ANY ELECTION?"
- 11 S 2. The election law is amended by adding a new section 5-507 to read 12 as follows:
- S 5-507. VOTER PRE-REGISTRATION AND EDUCATION ON VOTER PRE-REGISTRA14 TION. 1. PRE-REGISTRATION. A. A PERSON WHO IS AT LEAST SIXTEEN YEARS OF
 AGE AND WHO IS OTHERWISE QUALIFIED TO REGISTER TO VOTE MAY PRE-REGISTER
 TO VOTE, AND SHALL BE AUTOMATICALLY REGISTERED UPON REACHING THE AGE OF
 LIGIBILITY, FOLLOWING VERIFICATION OF THE PERSON'S QUALIFICATIONS AND
 ADDRESS.
- B. A PERSON WHO IS CURRENTLY (I) SEVENTEEN YEARS OF AGE ON THE DATE OF A PRIMARY ELECTION, (II) WHO WILL BE EIGHTEEN YEARS OF AGE ON THE DATE OF THE GENERAL ELECTION, AND (III) WHO IS OTHERWISE ELIGIBLE TO VOTE, MAY VOTE IN THE PRIMARY ELECTION.
- 23 2. ENCOURAGEMENT OF STUDENT VOTER REGISTRATION AND PRE-REGISTRATION.
 24 LOCAL BOARDS OF EDUCATION ARE REQUIRED TO ADOPT POLICIES TO PROMOTE

1 REGISTRATION AND PRE-REGISTRATION IN HIGH SCHOOLS. COMPLETION AND 2 SUBMISSION OF VOTER REGISTRATION OR PRE-REGISTRATION FORMS SHALL NOT BE 3 A COURSE REQUIREMENT OR GRADED ASSIGNMENT FOR STUDENTS.

S 3. This act shall take effect January 1, 2013. Effective immediately, the addition, amendment and/or repeal of any rules or regulations necessary for the implementation of this act on its effective date are authorized to be made on or before such date.
