AN ACT to amend the education law, in relation to certification of certified registered nurse anesthetists

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The education law is amended by adding a new section 6911 1 2 to read as follows:

3 CERTIFICATION OF CERTIFIED REGISTERED NURSE ANESTHETISTS. 1. 6911. S 4 FOR ISSUANCE OF A CERTIFICATE TO PRACTICE AS A CERTIFIED REGISTERED 5 NURSE ANESTHETIST, THE APPLICANT SHALL FULFILL THE FOLLOWING REQUIRE-6 MENTS: 7

(A) APPLICATION: FILE AN APPLICATION WITH THE DEPARTMENT;

8 (B) LICENSE: BE LICENSED AS A REGISTERED PROFESSIONAL NURSE THE IN 9 STATE;

10 EDUCATION: (I) HAVE SATISFACTORILY COMPLETED AN EDUCATIONAL (C) PROGRAM WHICH IS DESIGNED AND CONDUCTED TO PREPARE GRADUATES TO PRACTICE 11 12 IN THE SPECIALTY AREA OF NURSE ANESTHESIA; AND IS REGISTERED BY THE DEPARTMENT OR IN A PROGRAM ACCREDITED BY A NATIONAL BODY RECOGNIZED BY 13 THE DEPARTMENT OR DETERMINED BY THE DEPARTMENT TO BE THE EQUIVALENT; AND 14 15 (II) SUBMIT EVIDENCE OF CURRENT CERTIFICATION OR RECERTIFICATION BY A NATIONAL CERTIFYING BODY, RECOGNIZED BY THE DEPARTMENT; 16

17 (D) FEES: PAY A FEE TO THE DEPARTMENT OF FIFTY DOLLARS FOR AN INITIAL CERTIFICATE AUTHORIZING NURSE ANESTHESIA PRACTICE AND A TRIENNIAL REGIS-18 19 TRATION FEE OF THIRTY DOLLARS. AFTER A CERTIFIED REGISTERED NURSE 20 ANESTHETIST'S INITIAL REGISTRATION, REGISTRATION UNDER THIS SECTION 21 SHALL BE COTERMINOUS WITH THE CERTIFIED REGISTERED NURSE ANESTHETIST'S 22 REGISTRATION AS A REGISTERED PROFESSIONAL NURSE.

1 2. ONLY A PERSON CERTIFIED UNDER THIS SECTION SHALL USE THE TITLE 2 "CERTIFIED REGISTERED NURSE ANESTHETIST".

3 3. THE PROVISIONS OF THIS SECTION SHALL NOT APPLY TO ANY ACT OR PRAC-4 TICE AUTHORIZED BY ANY OTHER LAW, RULE, REGULATION OR CERTIFICATION.

5 4. THE COMMISSIONER IS AUTHORIZED TO PROMULGATE REGULATIONS TO IMPLE-6 MENT THE PROVISIONS OF THIS SECTION.

7 S 2. This act shall take effect on the one hundred eightieth day after 8 it shall have become a law, except that subdivision 2 of section 6911 of 9 the education law, as added by section one of this act shall take effect

10 three years after this act shall have become a law.
