AN ACT authorizing the county of Nassau to transfer ownership of certain
parklands to Conservation Partners, LLC

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The Nassau county legislature is hereby authorized and
2 empowered to convey the parkland property described in section two of
3 this act, upon terms to be fixed and determined by such county legisla-
4 ture, to Conservation Partners LLC, which terms and conditions shall
5 include the placement of a conservation easement on the property to be
6 conveyed prohibiting any future development on the property. This
7 authorization is based upon the unique facts and circumstances of this
8 particular parkland property which include: the property was acquired
9 for open space protection purposes and does not have any developed
10 recreational facilities; after conveyance, the open space features of
11 the property will be permanently protected through a conservation ease-
12 ment; and the conveyance is part of a larger conservation land trans-
13 action that will result in a net increase of more than thirty acres of
14 permanently protected open space in a densely developed area of Nassau
15 County.

16 S 2. The parkland referred to in section one of this act is located,
17 bounded and described as follows:

18 ALL that certain plot, piece or parcel of land with the buildings and
19 improvements thereon erected, situate, lying and being in the village of
20 Oyster Bay Cove, town of Oyster Bay, county of Nassau, state of New
21 York, being bounded and described as follows:

22 BEGINNING on the westerly side of Sandy Hill Road distant 1384.16 feet
23 northerly from the corner formed by the intersection of the northerly
24 side of Berry Hill Road with the westerly side of Sandy Hill Road;

10 S 3. The authorization provided in section one of this act shall be
11 effective only upon the condition that on or before the alienation and
12 conveyance of lands described in section two of this act, the county
13 shall acquire additional lands of equal or greater fair market value
14 than the lands being alienated, as described in section two of this act.
15 Such lands to be acquired, which shall be dedicated as parkland and for
16 open space protection purposes and shall be made available for the bene-
17 fit of the public as parkland, being bound and described as follows:

18 All that certain lot, piece or parcel of lands lying, situate and
19 being in the village of Old Brookville, town of Oyster Bay, county of
20 Nassau, State of New York, bounded and described as follows:

21 BEGINNING at a point formed by the intersection of the southerly side
22 of Chicken Valley Road and the westerly side of Hegemans Lane.

23 RUNNING THENCE along the westerly side of Hegemans Lane the following
24 two (2) courses:

25 1) S 13° 31' 47" W, 393.35 feet;
26 2) S 13° 22' 47" W, 1,648.88 feet to Lot 2 as shown on the "Map of M
27 and M Partners Development";

28 THENCE along said lot the following four (4) courses:

31 3) Northerly along the arc of a curve bearing to the right, having a

35 side of Chicken Valley Road;

49 S 4. In the event that the lands to be acquired, as described in
50 section three of this act, are not equal or greater in fair market value
51 than the lands being alienated, as described in section two of this act,
52 the county of Nassau shall dedicate the difference in the fair market
53 value for the acquisition of additional parklands and/or for capital
54 improvements to existing park and recreational facilities.

55 S 5. If the land that is the subject of this legislation has received
56 funding pursuant to the federal land and water conservation fund, the

1 discontinuance of parkland authorized by the provisions of this legis-
2 lation shall not occur until the municipality has complied with the
3 federal requirements pertaining to the conversion of parklands, includ-
4 ing satisfying the secretary of the interior that the discontinuance
5 will include all conditions which the secretary of the interior deems
6 necessary to assure the substitution of other lands shall be equivalent
7 in fair market value and recreational usefulness to the lands being
8 discontinued.

9 S 6. This act shall take effect immediately.
