AN ACT to amend the environmental conservation law, in relation to establishing the yearling buck protection program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The environmental conservation law is amended by adding a  
2     new section 11-0914 to read as follows:  
3     S 11-0914. YEARLING BUCK PROTECTION PROGRAM.  
4     1. DEFINITIONS. A. AN "ANTLERED DEER" IS DEFINED AS A DEER WITH AT  
5     LEAST ONE ANTLER MEASURING THREE INCHES OR MORE IN LENGTH.  
6     B. "WILDLIFE MANAGEMENT UNIT" MEANS WILDLIFE REGIONS AS DEMARCATED BY  
7     THE DEPARTMENT.  
8     2. RESTRICTIONS AND APPLICATION. A. ANY PERSON WHO HUNTS OR TAKES  
9     ANTLERED DEER UNDER A VALID PERMIT OR LICENSE DURING THE BOWHUNTING,  
10    REGULAR AND MUZZLELOADING DEER SEASONS IS RESTRICTED TO THE HUNTING OR  
11    TAKING OF ANTLERED DEER WITH AT LEAST ONE ANTLER WITH AT LEAST THREE  
12    POINTS. EACH POINT MUST BE AT LEAST ONE INCH LONG MEASURED FROM THE MAIN  
13    ANTLER BEAM.  
14    B. THIS PROGRAM APPLIES TO ALL PUBLIC AND PRIVATE LAND WITHIN THE  
15    SPECIFIED WILDLIFE MANAGEMENT UNITS.  
16    3. WILDLIFE MANAGEMENT UNITS. THESE RESTRICTIONS SHALL ONLY APPLY TO  
17    THAT PORTION OF WILDLIFE MANAGEMENT UNIT 3A SOUTH AND WEST OF STATE  
18    ROUTE TWENTY-EIGHT.  
19    4. EXEMPTIONS FROM REQUIREMENTS. HUNTERS UNDER THE AGE OF SEVENTEEN  
20    ARE EXEMPT FROM THE PROVISIONS OF THIS SECTION AND MAY TAKE ANY DEER  
21    WITH AN ANTLER OR ANTLERS MEASURING THREE INCHES OR MORE IN LENGTH.  
22    S 2. This act shall take effect immediately.
