AN ACT to amend the village law and the public officers law, in relation to the office of the assessor of the village of Haverstraw, Rockland county

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 3-300 of the village law is amended by adding a new subdivision 20 to read as follows:

3 20. NOTWITHSTANDING ANY PROVISIONS OF THIS CHAPTER OR ANY OTHER GENER-AL LAW, LOCAL LAW, ORDINANCE OR SPECIAL ACT, THE VILLAGE BOARD OF TRUS-4 5 TEES OF THE INCORPORATED VILLAGE OF HAVERSTRAW, ROCKLAND COUNTY, MAY BY 6 RESOLUTION, PROVIDE THAT THE OFFICE OF ASSESSOR OF SUCH VILLAGE MAY ΒE 7 HELD BY A PERSON WHO IS NOT A RESIDENT OF SUCH VILLAGE, PROVIDED THAT 8 SUCH PERSON RESIDES IN THE COUNTIES OF ROCKLAND, WESTCHESTER, ORANGE, OR 9 PUTNAM.

10 S 2. Section 3 of the public officers law is amended by adding a new 11 subdivision 58 to read as follows:

12 58. IN THE VILLAGE OF HAVERSTRAW, IN THE COUNTY OF ROCKLAND, THE 13 PROVISIONS OF THIS SECTION REOUIRING A PERSON TO BE A RESIDENT OF THE POLITICAL SUBDIVISION OR MUNICIPAL CORPORATION OF THE STATE FOR WHICH HE 14 OR SHE SHALL BE CHOSEN OR WITHIN WHICH HIS OR HER OFFICIAL FUNCTIONS ARE 15 16 REQUIRED TO BE EXERCISED, SHALL NOT PREVENT A PERSON FROM HOLDING THE 17 OFFICE OF ASSESSOR OF THE VILLAGE PROVIDED THAT SUCH PERSON RESIDES IN 18 THE COUNTY IN WHICH SUCH VILLAGE IS LOCATED OR AN ADJOINING COUNTY WITH-STATE OF NEW YORK. PROVIDED, HOWEVER, THE PERSON PERFORMING THE 19 THE INFUNCTIONS OF VILLAGE ASSESSOR IN ANY OTHER VILLAGE SHALL BE AN 20 ELECTOR OF SUCH VILLAGE, UNLESS OTHERWISE PROVIDED BY LAW. 21

22 S 3. This act shall take effect immediately.
