AN ACT to amend the alcoholic beverage control law, in relation to authorizing the liquor authority to issue certain licenses to manufacture and sell alcoholic beverages in a premises commonly known as a restaurant-brewer

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 10 of section 64-c of the alcoholic beverage  
2     control law, as added by chapter 538 of the laws of 1997, is amended to  
3     read as follows:  
4     10. (A) Except as provided in subdivisions seven, eight, nine, twelve,  
5     thirteen, fourteen and sixteen of this section, no person licensed under  
6     this section may be interested directly or indirectly in any other prem-  
7     ises in this state where alcoholic beverages are manufactured or sold.  
8     Any person who has an interest in premises eligible for conversion under  
9     subdivision nine of this section shall not be issued any license under  
10    this section unless and until a conversion application has been filed  
11    with and approved by the authority.  
12    (B) NOTWITHSTANDING THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVI-  
13    SION, THE AUTHORITY MAY ISSUE, TO THE HOLDER OF A RESTAURANT-BREWER'S  
14    LICENSE, A RETAIL LICENSE FOR ON PREMISES CONSUMPTION FOR THE FOLLOWING  
15    PREMISES:  
16    ALL THAT TRACT OR PARCEL OF LAND SITUATED IN THE CITY OF BUFFALO,  
17    COUNTY OF ERIE AND STATE OF NEW YORK, BEING PART OF INNER LOT NO. 200,  
18    DESCRIBED AS FOLLOWS:  
19    BEGINNING AT A POINT IN THE WEST LINE OF ELLICOTT STREET WHERE SAID  
20    WEST LINE IS INTERSECTED BY THE SOUTHERLY LINE OF SAID INNER LOT NO.  
21    200, WHICH POINT IS ONE HUNDRED EIGHTY-NINE AND SIX TENTHS (189.60) FEET  
22    SOUTH OF THE INTERSECTION OF SAID WEST LINE OF ELLICOTT STREET WITH THE  
23    SOUTH LINE OF HURON STREET; RUNNING THENCE WESTERLY ALONG THE SOUTH LINE

19 STREET ABOUT ONE HUNDRED EIGHTEEN (118) FEET; THENCE WESTERLY ONE  
20 HUNDRED TWENTY-NINE AND FIVE HUNDREDTHS (129.05) FEET TO ELLICOTT  
21 STREET; THENCE SOUTHERLY ON THE EAST LINE OF ELLICOTT STREET TWENTY-FOUR  
22 (24) FEET TO THE PLACE OF BEGINNING, BE THE SAME MORE OR LESS.

26 PREMISES.

27 ALL THAT TRACT OR PARCEL OF LAND, SITUATED IN THE CITY OF BUFFALO,  
28 COUNTY OF ERIE AND STATE OF NEW YORK, BEING PART OF INNER LOT NUMBER  
29 SEVENTY-ONE (71), DESCRIBED AS FOLLOWS:

30 BEGINNING IN THE WESTERLY LINE OF PEARL STREET AT THE SOUTHEAST CORNER  
31 OF INNER LOT NUMBER SEVENTY ONE (71), WHICH IS ALSO THE NORTH LINE OF  
32 INNER LOT NUMBER SEVENTY (70), ONE HUNDRED TWENTY AND THREE TWELFTHS  
33 (120 3/12) FEET TO A POINT DISTANT EASTERLY FROM THE EASTERLY LINE OF  
34 FRANKLIN STREET ONE HUNDRED TWELVE (112) FEET MEASURED ALONG SAID SOUTH

6 DISTINGUISHED AS THE EAST FIFTEEN (15) FEET OF SUBDIVISION LOT NUMBER  
7 NINE (9) AND THE WEST TWENTY (20) FEET OF SUBDIVISION LOT NUMBER ELEVEN  
8 (11) AS SHOWN AS MAP FILED IN ERIE COUNTY CLERK'S OFFICE UNDER COVER  
9 NUMBER 24, AMHERST STREET, NORTHWEST SIDE, FOUR HUNDRED FIFTY (450) FEET  
10 EAST OF MILITARY ROAD.
