AN ACT to amend the social services law and the public health law, in relation to mandatory reporting of suspected child abuse or maltreatment at summer day camps

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (a) of subdivision 1 of section 413 of the social services law, as amended by chapter 91 of the laws of 2011, is amended to read as follows:

following persons and officials are required to report or (a) The 5 cause a report to be made in accordance with this title when they have reasonable cause to suspect that a child coming before them in their 7 professional or official capacity is an abused or maltreated child, or when they have reasonable cause to suspect that a child is an abused or 8 9 maltreated child where the parent, guardian, custodian or other person 10 legally responsible for such child comes before them in their profes-11 sional or official capacity and states from personal knowledge facts, conditions or circumstances which, if correct, would render the child an 12 abused or maltreated child: any physician; registered physician assist-13 14 ant; surgeon; medical examiner; coroner; dentist; dental hygienist; 15 osteopath; optometrist; chiropractor; podiatrist; resident; intern; 16 psychologist; registered nurse; social worker; emergency medical technician; licensed creative arts therapist; licensed marriage and family 17 therapist; licensed mental health counselor; licensed psychoanalyst; 18 hospital personnel engaged in the admission, examination, care or treat-19 20 ment of persons; a Christian Science practitioner; school official, 21 which includes but is not limited to COLLEGE COACH, ATHLETIC DIRECTOR, 22 PROFESSOR, GRADUATE ASSISTANT, COLLEGE ADMINISTRATOR, COLLEGE PRESIDENT, school teacher, school guidance counselor, school psychologist, school 23 school nurse, school administrator or other school 24 social worker,

- S 2. Subdivision 2 of section 1392 of the public health law, as amended by chapter 439 of the laws of 2009, is amended to read as follows:
- "Summer day camp" shall mean a property consisting of a tract of land and any tents, vehicles, buildings or other structures that may be pertinent to its use, any part of which may be occupied on a scheduled basis at any time between June first and September fifteenth in any year by children under sixteen years of age under general supervision, for the purpose of ANY indoor or outdoor organized group activities, involving ONE OR MORE: (I) nonpassive recreational activities with significant as such activities are defined by the department in injury, risk of rules and regulations, OR (II) EDUCATIONAL PROGRAMS OR ACTIVITIES, for a period of less than twenty-four hours on any day the property is occupied, and on which no provisions are made for overnight occupancy by such children. The commissioner shall have the power to except by rule from this article and the sanitary code a place, facility or activity the intent of this definition, PROVIDED THAT NO is not within EXCEPTION MAY BE GRANTED TO A SUMMER DAY CAMP WHICH IS DEDICATED THAT ACTIVITY MEETS THE CRITERIA OF A NONPASSIVE ACTIVITY ΙF RECREATIONAL ACTIVITY WITH SIGNIFICANT RISK OF INJURY OR IS AN TIONAL PROGRAM OR ACTIVITY.
- 38 S 3. This act shall take effect on the one hundred twentieth day after 39 it shall have become a law. Effective immediately, the addition, amend-40 ment and/or repeal of any rule or regulation necessary for the implemen-41 tation of this act on its effective date is authorized to be made on or 42 before such date.
