AN ACT to amend the education law, in relation to authorizing the board of trustees of the university of Rochester to designate security staff as peace officers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 6311 2 to read as follows:

3 6311. DESIGNATION OF PEACE OFFICERS AT THE UNIVERSITY OF ROCHESTER. S 4 1. THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ROCHESTER SHALL HAVE THE AUTHORITY TO APPOINT SECURITY OFFICERS FOR SUCH UNIVERSITY AND, IN ITS 5 6 DISCRETION, TO DESIGNATE OR TO REVOKE THE DESIGNATION OF ONE OR MORE 7 THAN ONE SECURITY OFFICER AS A PEACE OFFICER. A SECURITY OFFICER SO 8 DESIGNATED SHALL HAVE THE POWERS OF A PEACE OFFICER AS SET FORTH IN9 2.20 OF THE CRIMINAL PROCEDURE LAW. A SECURITY OFFICER DESIG-SECTION 10 NATED AS A PEACE OFFICER MUST HAVE SATISFACTORILY COMPLETED OR COMPLETE, WITHIN ONE YEAR OF THE DATE OF SUCH DESIGNATION, A COURSE OF 11 LAW ENFORCEMENT TRAINING PRESCRIBED BY THE MUNICIPAL POLICE TRAINING COUNCIL 12 13 CONSULTATION WITH THE UNIVERSITY BOARD OF TRUSTEES. A PEACE OFFICER IN SO DESIGNATED MAY POSSESS AND CARRY A BATON AND PEPPER FOAM AS A PART OF 14 15 ON DUTY EMPLOYMENT ONLY IF AUTHORIZED TO DO SO BY THE PRESIDENT OF THE GEOGRAPHICAL AREA OF EMPLOYMENT OF A PEACE OFFICER SO 16 UNIVERSITY. THE DESIGNATED IS THE CAMPUS AND OTHER PROPERTY OF THE UNIVERSITY, INCLUDING 17 18 THAT PORTION OF A PUBLIC HIGHWAY WHICH CROSSES OR ABUTS SUCH PROPERTY, 19 RESIDENTIAL OR OTHER FACILITIES OWNED, OPERATED OR MAINTAINED BY A AND 20 NOT-FOR-PROFIT ENTITY ASSOCIATED WITH THE UNIVERSITY OF ROCHESTER FOR WHICH SUCH UNIVERSITY PROVIDES SECURITY. 21

2. THE APPOINTMENT OF SECURITY OFFICERS AT THE UNIVERSITY OF ROCHESTER 22 SHALL BE GOVERNED BY AND CONFORM WITH CIVIL SERVICE LAWS, RULES AND 23 24 REGULATIONS, IF APPLICABLE TO THE UNIVERSITY AND ITS EMPLOYEES. THE 25 DESIGNATION OF A SECURITY OFFICER AS A PEACE OFFICER SHALL BE BASED ON 26 QUALIFICATIONS ESTABLISHED BY THE UNIVERSITY BOARD OF TRUSTEES, AND IN ACCORDANCE WITH SENIORITY. FOR PURPOSES OF THIS SUBDIVISION, "SENIORITY" 27

A SECURITY OFFICER WHO HAS BEEN DESIGNATED A PEACE OFFICER MAY HAVE 4 SUCH DESIGNATION SUSPENDED OR REMOVED PURSUANT TO PROCEDURES ESTABLISHED 5 BY THE UNIVERSITY OR IN COMPLIANCE WITH ANY LOCAL COLLECTIVE BARGAINING 6 AGREEMENT, IF APPLICABLE TO THE UNIVERSITY AND ITS EMPLOYEES. 7 4. THE DESIGNATION OF PEACE OFFICERS PURSUANT TO THIS SECTION SHALL 8 NOT BE DEEMED TO SUPERSEDE IN ANY WAY THE AUTHORITY OF OTHER PEACE OFFI-9 CERS AND POLICE OFFICERS.

10 5. NOTHING CONTAINED IN THIS SECTION SHALL BE CONSTRUED TO: (I) ALTER ANY EXISTING COLLECTIVE BARGAINING AGREEMENT; (II) DIMINISH THE 11 RIGHTS OF EMPLOYEES PURSUANT TO AN EXISTING COLLECTIVE BARGAINING AGREEMENT; 12 (III) AFFECT EXISTING LAW WITH RESPECT TO AN APPLICATION TO THE 13 PUBLIC 14 EMPLOYMENT RELATIONS BOARD SEEKING DESIGNATION BY THE BOARD THAT CERTAIN PERSONS ARE MANAGERIAL OR CONFIDENTIAL; OR (IV) ALTER OR RESTRICT THE 15 16 POWER OF A COUNTY OR UNIVERSITY SPONSOR OR EMPLOYEE ORGANIZATION ΤO NEGOTIATE WITH RESPECT TO AN ALTERNATE METHOD OF APPOINTMENT 17 OR PROMOTION OF SECURITY OFFICERS. 18
