AN ACT to amend the mental hygiene law, in relation to averting retraumatization of victims of sexual offenses in a behavioral health outpatient setting

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The mental hygiene law is amended by adding a new section 2 7.44 to read as follows:
- 3 S 7.44 VICTIMS OF SEXUAL OFFENSES; OUTPATIENT GROUP SETTING.
- 4 THE OFFICE SHALL DEVELOP GUIDELINES AND PROCEDURES REGARDING VICTIMS 5 OF SEXUAL OFFENSES RECEIVING SERVICES IN AN OUTPATIENT GROUP SETTING.
- 6 SUCH GUIDELINES AND PROCEDURES SHALL OUTLINE BEST PRACTICES PROVIDERS 7 MAY USE WHEN PROVIDING SERVICES TO VICTIMS OF SEXUAL ABUSE IN AN EFFORT
- 7 MAY USE WHEN PROVIDING SERVICES TO VICTIMS OF SEXUAL ABUSE IN AN EFFORT 8 TO AVERT RETRAUMATIZATION BY KNOWN SEX OFFENDERS. SUCH BEST PRACTICES

- 14 S 2. The mental hygiene law is amended by adding a new section 19.43 15 to read as follows:
- 16 S 19.43 VICTIMS OF SEXUAL OFFENSES; OUTPATIENT GROUP SETTING.
- 17 THE OFFICE SHALL DEVELOP GUIDELINES AND PROCEDURES REGARDING VICTIMS 18 OF SEXUAL OFFENSES RECEIVING SERVICES IN AN OUTPATIENT GROUP SETTING.
- 18 OF SEXUAL OFFENSES RECEIVING SERVICES IN AN OUTPATIENT GROUP SETTING. 19 SUCH GUIDELINES AND PROCEDURES SHALL OUTLINE BEST PRACTICES PROVIDERS

- 27 S 3. This act shall take effect immediately.
