AN ACT to amend the mental hygiene law, in relation to averting retraumatization of victims of sexual offenses in a behavioral health outpatient setting

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The mental hygiene law is amended by adding a new section 2 7.44 to read as follows:
- 3 S 7.44 VICTIMS OF SEXUAL OFFENSES; OUTPATIENT GROUP SETTING.
- THE OFFICE SHALL DEVELOP GUIDELINES REGARDING VICTIMS OF RECEIVING SERVICES IN AN OUTPATIENT GROUP SETTING. SUCH GUIDE-LINES SHALL OUTLINE BEST PRACTICES PROVIDERS MAY USE WHEN PROVIDING 7 TO VICTIMS OF SEXUAL ABUSE IN AN EFFORT TO AVERT RETRAUMATIZA-SERVICES 8 TION BY KNOWN SEX OFFENDERS. SUCH BEST PRACTICES SHALL, TO THE 9 EXTENT POSSIBLE, BE BASED ON EVIDENCE BASED PRACTICES. IN CREATING SUCH GUIDELINES, THE OFFICE SHALL CONSULT WITH STAKEHOLDERS. SUCH STAKEHOLD-10 SHALL INCLUDE, BUT NOT BE LIMITED TO, REPRESENTATIVES OF CONSUMER 11 12 ADVOCATES, PROVIDERS AND VICTIM RIGHTS GROUPS.
- 13 S 2. The mental hygiene law is amended by adding a new section 19.43 14 to read as follows:
- 15 S 19.43 VICTIMS OF SEXUAL OFFENSES; OUTPATIENT GROUP SETTING.
- THE OFFICE SHALL DEVELOP GUIDELINES REGARDING VICTIMS OF SEXUAL OFFENSES RECEIVING SERVICES IN AN OUTPATIENT GROUP SETTING. SUCH GUIDE-LINES SHALL OUTLINE BEST PRACTICES PROVIDERS MAY USE WHEN PROVIDING SERVICES TO VICTIMS OF SEXUAL ABUSE IN AN EFFORT TO AVERT RETRAUMATIZA-
- 20 TION BY KNOWN SEX OFFENDERS. SUCH BEST PRACTICES SHALL, TO THE GREATEST
- 21 EXTENT POSSIBLE, BE BASED ON EVIDENCE BASED PRACTICES. IN CREATING SUCH 22 GUIDELINES, THE OFFICE SHALL CONSULT WITH STAKEHOLDERS. SUCH STAKEHOLD-
- 23 ERS SHALL INCLUDE, BUT NOT BE LIMITED TO, REPRESENTATIVES OF CONSUME.
- 24 ADVOCATES, PROVIDERS AND VICTIM RIGHTS GROUPS.
- 25 S 3. This act shall take effect immediately.
