AN ACT to amend the mental hygiene law, in relation to duties of providers of services for the developmentally disabled

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- The mental hygiene law is amended by adding a new section 16.25 to read as follows:
- S 16.25 SURVEILLANCE CAMERAS.

- (A) (I) SURVEILLANCE CAMERAS WITH SOUND CAPABILITY SHALL BE ALL PUBLIC COMMON AREAS INCLUDING, BUT NOT LIMITED TO, ALL COMMON LIVING AREAS, DINING AREAS, HALLWAYS, CLASSROOMS AND TIME-OUT ROOMS 7 GROUP HOMES, RESIDENTIAL AND DAY SCHOOLS AND PROGRAMS LICENSED, CERTIFIED, FUNDED OR OPERATED BY THE OFFICE WHICH PROVIDE 8 SERVICES FOR 9 CHILDREN OR ADULTS WITH MENTAL OR PHYSICAL DISABILITIES.
- 10 (II) ALL PUBLIC COMMON AREAS INCLUDING, BUT NOT LIMITED TO, ALL COMMON LIVING AREAS, DINING AREAS, HALLWAYS, CLASSROOMS AND TIME-OUT ROOMS OF A 11 FACILITY PROVIDING RESIDENTIAL CARE TO YOUTH AS SUCH TERM IS DEFINED IN 12 13 PARAGRAPH (A) OR (B) OF SUBDIVISION FOUR OF SECTION FOUR TWELVE-A OF THE SOCIAL SERVICES LAW SHALL BE EQUIPPED WITH SURVEILLANCE 14 15 CAMERAS WITH SOUND CAPABILITY.
- (B) IN ALL RESIDENTIAL FACILITIES STATEWIDE, FOR CHILDREN WITH MENTAL 16 DISABILITIES CERTIFIED, LICENSED, FUNDED OR OPERATED BY THE OFFICE, 17 SURVEILLANCE CAMERAS MAY BE PLACED IN A CHILD'S, AGE THIRTEEN OR 18 19 ER, ROOM AT THE REQUEST OF AND WITH THE CONSENT OF THE CHILD'S PARENT OR 20 GUARDIAN AND ONLY IF THE CHILD IS IN A SINGLE OCCUPANCY BEDROOM.
- FAILS TO THE PROVISIONS OF THIS 21 ANY PROVIDER THATIMPLEMENT 22 SECTION SHALL BE SUBJECTED TO A FINE OF ONE THOUSAND DOLLARS PER DAY 23 NONCOMPLIANCES.
- 24 2. This act shall take effect one year after it shall have become a 25 law.
