AN ACT to amend the executive law, in relation to providing for the issuance of a certificate of ethics course completion to professional fundraisers and charitable organizations who complete a course of instruction in the law and ethics of fundraising

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The executive law is amended by adding a new section 178 to 2 read as follows:

3 S 178. COURSE OF INSTRUCTION IN THE LAW AND THE ETHICS OF FUNDRAISING 4 PHILANTHROPY. 1. ANY PROFESSIONAL FUNDRAISER, PROFESSIONAL SOLICI-AND 5 TOR, OR FUNDRAISING COUNSEL, WHO IS AN INDIVIDUAL REQUIRED TO REGISTER б PURSUANT TO SECTION ONE HUNDRED SEVENTY-THREE OF THIS ARTICLE, WHO SHALL 7 HAVE COMPLETED AN ACCEPTABLE COURSE OF INSTRUCTION IN THE LAW AND ETHICS 8 FUNDRAISING AND PHILANTHROPY SHALL BE ENTITLED TO A CERTIFICATE OF OF ETHICS COURSE COMPLETION BY THE ATTORNEY GENERAL. SUCH INDIVIDUALS SHALL 9 VERIFY ON THEIR REGISTRATION OR RE-REGISTRATION FORM THAT THEY HAVE 10 COMPLETED SUCH COURSE AND SHALL PROVIDE DOCUMENTATION OF SUCH COMPLETION 11 12 AT THE REQUEST OF THE ATTORNEY GENERAL.

13 2. ANY PROFESSIONAL FUNDRAISER, PROFESSIONAL SOLICITOR, OR FUNDRAISING 14 COUNSEL WHICH IS AN ORGANIZATION, GROUP, ASSOCIATION, PARTNERSHIP, CORPORATION, OR ANY COMBINATION THEREOF REQUIRED TO REGISTER PURSUANT TO 15 SECTION ONE HUNDRED SEVENTY-THREE OF THIS ARTICLE, SEVENTY-FIVE PERCENT 16 WHOSE EMPLOYEES RESPONSIBLE FOR THE HIRING, TRAINING OR SUPERVISION 17 OF OF EMPLOYEES ENGAGED IN THE FUNDRAISING ACTIVITIES OF THE ORGANIZATION, 18 19 GROUP, ASSOCIATION, PARTNERSHIP OR CORPORATION COMPLETE AN ACCEPTABLE 20 COURSE OF INSTRUCTION IN THE LAW AND ETHICS OF FUNDRAISING AND PHILAN-THROPY, SHALL BE ENTITLED TO A CERTIFICATE OF ETHICS COURSE COMPLETION 21 BY THE ATTORNEY GENERAL. SUCH PROFESSIONAL FUNDRAISER, 22 PROFESSIONAL 23 SOLICITOR, OR FUNDRAISING COUNSEL SHALL VERIFY ON ITS REGISTRATION OR 24 RE-REGISTRATION FORM THAT SUCH VOLUNTEERS OR EMPLOYEES HAVE COMPLETED 25 SUCH COURSE AND SHALL PROVIDE DOCUMENTATION OF SUCH COMPLETION AT THE 26 REQUEST OF THE ATTORNEY GENERAL.

3. ANY CHARITABLE ORGANIZATION, INCLUDING ANY CHARITABLE ORGANIZATION 1 REQUIRED TO BE REGISTERED PURSUANT TO ARTICLE EIGHT OF THE ESTATES, 2 3 POWERS AND TRUSTS LAW, REQUIRED TO REGISTER PURSUANT TO SECTION ONE 4 HUNDRED SEVENTY-TWO OF THIS ARTICLE, SEVENTY-FIVE PERCENT OF WHOSE EMPLOYEES RESPONSIBLE FOR THE HIRING, TRAINING OR SUPERVISION OF EMPLOY-5 EES ENGAGED IN THE FUNDRAISING ACTIVITIES OF THE CHARITABLE ORGANIZATION 6 7 COMPLETE AN ACCEPTABLE COURSE OF INSTRUCTION IN THE LAW AND ETHICS OF FUNDRAISING AND PHILANTHROPY SHALL BE ENTITLED TO A CERTIFICATE OF ETHICS COURSE COMPLETION BY THE ATTORNEY GENERAL. SUCH CHARITABLE 8 9 10 ORGANIZATION SHALL VERIFY ON ITS REGISTRATION OR RE-REGISTRATION FORM THAT SUCH VOLUNTEERS OR EMPLOYEES HAVE COMPLETED SUCH COURSE AND SHALL 11 PROVIDE DOCUMENTATION OF SUCH COMPLETION AT THE REQUEST OF THE ATTORNEY 12 13 GENERAL.

4. THE ATTORNEY GENERAL SHALL ANNUALLY PUBLISH THE NAMES OF ANY
PROFESSIONAL FUNDRAISER, PROFESSIONAL SOLICITOR, FUNDRAISING COUNSEL OR
CHARITABLE ORGANIZATION THAT HAS BEEN GRANTED A CERTIFICATE OF ETHICS
COURSE COMPLETION IN ANY REPORT PREPARED TO ASSIST THE PUBLIC IN DETERMINING WHICH CHARITABLE ORGANIZATIONS TO SUPPORT, AND THE CHARITIES
BUREAU REGISTRY MAINTAINED BY THE ATTORNEY GENERAL SHALL INDICATE THAT A
CERTIFICATE OF ETHICS COURSE COMPLETION HAS BEEN GRANTED.

21 5. FOR THE PURPOSE OF THIS SECTION, "ACCEPTABLE COURSE" SHALL MEAN A COURSE OF INSTRUCTION APPROVED BY THE ATTORNEY GENERAL, IN CONSULTATION 22 WITH THE EDUCATION DEPARTMENT, IN RELATION TO THE LAW AND ETHICS OF 23 FUNDRAISING AND PHILANTHROPY. UNIVERSITIES AND COLLEGES STATEWIDE, AND 24 25 PROFESSIONAL TRADE ASSOCIATIONS THAT ESTABLISH PROFESSIONAL STANDARDS 26 AND PROVIDE TRAINING AND RESOURCES FOR INDIVIDUALS ENGAGING IN PROFES-27 SIONAL FUNDRAISING, MAY OFFER AN ACCEPTABLE COURSE THROUGH CLASSROOM TRAINING AND/OR BY DISTANCE LEARNING, AND SHALL PROVIDE DOCUMENTATION OF 28 COMPLETION TO THOSE WHO COMPLETE THE COURSE. ANY PERSON TAKING THE 29 COURSE MAY ELECT TO DO SO BY EITHER METHOD OFFERED. COURSES PROVIDED BY 30 DISTANCE LEARNING SHALL BE SUBJECT TO ALL REGULATIONS ESTABLISHED BY THE 31 32 STATE EDUCATION DEPARTMENT FOR SUCH COURSES.

33 S 2. This act shall take effect immediately.
