- AN ACT to amend the education law, in relation to enacting the "New York state YouthBuild act"; setting program requirements; authorizing the commissioner of education to make grants to eligible YouthBuild programs and to establish application requirements; expanding the number of YouthBuild programs in New York state; and making an appropriation therefor

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as 2 the "New York state YouthBuild act".

3 S 2. Legislative intent. The legislature seeks to support economically 4 disadvantaged youth, especially youth who have not finished high school, 5 to obtain the education, work experience skills training, personal coun-6 seling, leadership development skills training, job placement assist-7 ance, and long-term follow-up services necessary for them to achieve 8 permanent economic self-sufficiency, while at the same time providing 9 valuable community service that addresses urgent community needs including the demand for affordable housing and the need for young role models 10 11 and mentors for younger teenagers and children.

12 The legislature further intends to foster the development of leader-13 ship skills and a commitment to community development among youth and to 14 ensure maximum educational achievement of program participants through

1 high school diploma or the equivalent attainment and transition to 2 institutions of higher education, where appropriate.

The legislature further intends to provide communities the opportunity to establish or rebuild neighborhood stability in economically depressed and low-income areas, as well as historic areas requiring restoration or preservation, while providing economically disadvantaged youth and youth who have not finished high school an opportunity for a meaningful participation in society.

9 The legislature further intends to allow communities to expand the 10 supply of affordable housing for homeless and other low-income individ-11 uals by utilizing the energies and talents of economically disadvantaged 12 youth and young people who have not graduated from high school.

13 The legislature also intends to foster the development of leadership 14 skills and a commitment to community development among youth.

15 S 3. The education law is amended by adding a new section 4608 to read 16 as follows:

17 4608. YOUTHBUILD ACT; PROGRAM REQUIREMENTS; S THE NEW YORK STATE 1. THE COMMISSIONER IS AUTHORIZED TO MAKE GRANTS TO 18 SERVICES. ELIGIBLE 19 APPLICANTS FOR THE PURPOSE OF CARRYING OUT YOUTHBUILD PROGRAMS AS 20 APPROVED UNDER THIS FUNDED PURSUANT SECTION. ALL PROGRAMS TO THE 21 PROVISIONS OF THIS SECTION SHALL REFLECT STRONG YOUTH AND COMMUNITY 22 INVOLVEMENT. IN ADDITION, FUNDING PROVIDED UNDER THIS SECTION MAY BE 23 USED BY EACH YOUTHBUILD PROGRAM TO PROVIDE THE FOLLOWING SERVICES:

24 THE TRAINING COSTS FOR THE REHABILITATION OR CONSTRUCTION OF HOUS-Α. 25 ING AND RELATED FACILITIES TO BE USED FOR THE PURPOSE OF PROVIDING 26 HOMEOWNERSHIP FOR DISADVANTAGED PERSONS, RESIDENTIAL HOUSING FOR HOME-LESS INDIVIDUALS, AND LOW-INCOME AND VERY LOW-INCOME FAMILIES, OR TRAN-27 28 SITIONAL HOUSING FOR PERSONS WHO ARE HOMELESS, HAVE DISABILITIES, ARE ILL, ARE DEINSTITUTIONALIZED, OR HAVE SPECIAL NEEDS, OR THE 29 REHABILI-CONSTRUCTION OF COMMUNITY FACILITIES OWNED BY NOT-FOR-PROFIT 30 TATION OR 31 PUBLIC AGENCIES.

B. THE COST OF PROVIDING TRAINING AND PLACEMENT IN THE GROWING EMPLOY-MENT SECTORS OF HEALTHCARE AND TECHNOLOGY.

34 C. THE COST OF INTEGRATED EDUCATION AND WORK EXPERIENCE SKILLS TRAIN-ING SERVICES AND ACTIVITIES WHICH ARE EVENLY DIVIDED WITHIN THE PROGRAM, 35 LEAST FIFTY PERCENT OF STUDENTS' TIME SPENT IN CLASSROOM-BASED 36 WITH AT 37 INSTRUCTION, COUNSELING AND LEADERSHIP DEVELOPMENT INSTRUCTION AND AT 38 FORTY PERCENT OF THEIR TIME SPENT IN WORK EXPERIENCE TRAINING ON LEAST 39 THE CONSTRUCTION SITE, OR IN HEALTHCARE OR TECHNOLOGY TRAINING PROGRAMS. 40 THE PROGRAM SHALL INCLUDE, AT MINIMUM, THE FOLLOWING ELEMENTS:

(1) THE COST OF AN EDUCATION COMPONENT WHICH INCLUDES: 41 BASIC SKILLS INSTRUCTION, SECONDARY EDUCATION SERVICES, AND OTHER ACTIVITIES DESIGNED 42 43 LEAD THE ATTAINMENT OF A HIGH SCHOOL DIPLOMA OR ITS EQUIVALENT. ТΟ ΤO 44 THE CURRICULUM FOR THIS COMPONENT SHALL INCLUDE MATH, LANGUAGE ARTS, VOCATIONAL EDUCATION, LIFE SKILLS TRAINING, SOCIAL STUDIES RELATED TO 45 THE CULTURAL AND COMMUNITY HISTORY OF THE STUDENTS, LEADERSHIP 46 SKILLS, 47 TOPICS AT THE DISCRETION OF THE PROGRAMS. BILINGUAL SERVICES AND OTHER 48 SHALL BE AVAILABLE FOR INDIVIDUALS WITH LIMITED-ENGLISH PROFICIENCY. THE 49 DESIRED MINIMUM TEACHER/STUDENT CLASSROOM RATIO SHALL BE ONE TEACHER FOR 50 EVERY FIFTEEN STUDENTS.

51 (2) A WORK EXPERIENCE AND SKILLS TRAINING COMPONENT PRE-APPRENTICESHIP ACTIVITIES 52 PROGRAM THAT INCLUDES CONSTRUCTION AND REHABILITATION 53 DESCRIBED INPARAGRAPH A OF THIS SUBDIVISION. THE PROCESS OF 54 CONSTRUCTION MUST BE COUPLED WITH WORK EXPERIENCE SKILLS TRAINING AND 55 WITH CLOSE ON-SITE SUPERVISION BY EXPERIENCED TRAINERS. THE CURRICULUM FOR THIS COMPONENT SHALL CONTAIN A SET OF LOCALLY AGREED UPON SKILLS AND 56

1 COMPETENCIES THAT ARE SYSTEMATICALLY TAUGHT, WITH STUDENTS' MASTERY 2 ASSESSED INDIVIDUALLY ON A REGULAR, ONGOING BASIS. SAFETY SKILLS SHALL 3 BE TAUGHT AT THE OUTSET. THE DESIRED TRAINER/STUDENT RATIO SHALL BE ONE 4 TRAINER FOR EVERY SEVEN STUDENTS. THE WORK EXPERIENCE AND SKILLS TRAIN-5 ING COMPONENT SHALL BE COORDINATED TO THE MAXIMUM EXTENT FEASIBLE WITH 6 PREAPPRENTICESHIP AND APPRENTICESHIP PROGRAMS.

7 (3) ASSISTANCE IN ATTAINING POST SECONDARY EDUCATION AND REQUIRED 8 FINANCIAL AID SHALL BE MADE AVAILABLE TO PARTICIPANTS PRIOR TO GRADU-9 ATION.

10 D. THE COST OF COUNSELING SERVICES DESIGNED TO ASSIST PARTICIPANTS TO 11 POSITIVELY PARTICIPATE IN SOCIETY, WHICH SHOULD INCLUDE ALL OF THE FOLLOWING IF NECESSARY: OUTREACH, ASSESSMENT, AND ORIENTATION; 12 INDIVID-UAL AND PEER COUNSELING; LIFE SKILLS TRAINING; DRUG AND ALCOHOL ABUSE 13 14 EDUCATION AND PREVENTION; AND REFERRAL TO APPROPRIATE DRUG REHABILI-TATION, MEDICAL, MENTAL HEALTH, LEGAL, HOUSING, AND OTHER SERVICES AND 15 RESOURCES IN THE COMMUNITY. THE DESIRED COUNSELOR/PARTICIPANT RATIO 16 17 SHALL BE ONE COUNSELOR FOR EVERY TWENTY-EIGHT STUDENTS.

18 E. THE COST OF LEADERSHIP DEVELOPMENT TRAINING THAT PROVIDES PARTIC-19 IPANT WITH MEANINGFUL OPPORTUNITIES TO DEVELOP LEADERSHIP SKILLS SUCH AS 20 DECISION MAKING, PROBLEM SOLVING, AND NEGOTIATING. THE PROGRAM SHALL 21 ALSO ENCOURAGE PARTICIPANTS TO DEVELOP STRONG PEER GROUP TIES THAT 22 SUPPORT THEIR MUTUAL PURSUIT OF SKILLS AND VALUES.

ALL PROGRAMS MUST ESTABLISH A YOUTH COUNCIL IN WHICH PARTICIPANTS ARE AFFORDED OPPORTUNITIES TO DEVELOP PUBLIC SPEAKING AND NEGOTIATING SKILLS, AND MANAGEMENT AND POLICYMAKING PARTICIPATION IN SPECIFIC ASPECTS OF THE PROGRAM.

27 2. A TRAINING SUBSIDY, LIVING ALLOWANCE, OR STIPEND THAT SHALL BE NO 28 LESS THAN MINIMUM WAGE MUST BE PROVIDED TO PROGRAM PARTICIPANTS FOR THE TIME SPENT AT THE WORKSITE IN CONSTRUCTION TRAINING, HEALTH CARE OR 29 INFORMATION TECHNOLOGY SERVICES. FOR THOSE PARTICIPANTS WHO RECEIVE 30 PUBLIC ASSISTANCE, THIS TRAINING SUBSIDY, LIVING ALLOWANCE, OR STIPEND 31 32 SHALL NOT AFFECT THEIR HOUSING BENEFITS, MEDICAL BENEFITS, CHILD CARE BENEFITS OR FOOD STAMP BENEFITS. STIPENDS AND WAGES MAY BE DISTRIBUTED 33 IN A MANNER THAT OFFERS INCENTIVES FOR GOOD PERFORMANCE. 34

35 A. FULL TIME PARTICIPATION IN A YOUTHBUILD PROGRAM SHALL BE OFFERED 36 FOR A PERIOD OF NOT LESS THAN SIX MONTHS AND NOT MORE THAN TWENTY-FOUR 37 MONTHS.

38 B. A CONCENTRATED EFFORT, FOR THOSE PARTICIPANTS WHO CHOOSE NOT TO 39 IMMEDIATELY ENROLL IN AN INSTITUTION OF HIGHER EDUCATION, SHALL BE MADE 40 TO FIND CONSTRUCTION, CONSTRUCTION-RELATED, AND NONCONSTRUCTION JOBS AS WELL AS JOBS IN THE FIELDS OF HEALTHCARE AND TECHNOLOGY FOR ALL GRADU-41 ATES OF THE PROGRAM WHO HAVE PERFORMED WELL. THE WORK EXPERIENCE SKILLS 42 43 TRAINING CURRICULUM SHALL PROVIDE PARTICIPANTS WITH BASIC PREPARATION 44 FOR SEEKING AND MAINTAINING A JOB. FOLLOW-UP COUNSELING AND ASSISTANCE 45 IN JOB-SEEKING SHALL ALSO BE PROVIDED TO PARTICIPANTS FOR THE TWELVE MONTHS FOLLOWING GRADUATION FROM THE PROGRAM. 46

47 C. ALL PROGRAMS SERVING TWENTY-EIGHT TRAINEES OR MORE ARE REQUIRED TO 48 HAVE A FULL-TIME DIRECTOR RESPONSIBLE FOR THE COORDINATION OF ALL 49 ASPECTS OF THE YOUTHBUILD PROGRAM.

50 3. IMPLEMENTATION GRANTS MAY BE USED TO CARRY OUT THE ACTIVITIES LIST-51 ED IN SUBDIVISIONS ONE AND TWO OF THIS SECTION. OTHER ELIGIBLE ACTIV-52 ITIES INCLUDE THE FOLLOWING:

53 A. ADMINISTRATIVE COSTS OF THE APPLICANT UP TO FIFTEEN PERCENT OF THE 54 AMOUNT OF ASSISTANCE PROVIDED.

55 B. DEFRAYING COSTS FOR THE ONGOING TRAINING AND TECHNICAL ASSISTANCE 56 NEEDS OF THE RECIPIENT THAT ARE RELATED TO DEVELOPING AND CARRYING OUT A

YOUTHBUILD PROGRAM INCLUDING: THE COMMISSIONER SHALL RESERVE 1 FIVE 2 PERCENT OF THE NEW YORK YOUTHBUILD PROGRAM APPROPRIATIONS TO ENTER INTO 3 CONTRACT WITH YOUTHBUILD USA, INC. TO PROVIDE ASSISTANCE IN THE 4 PROVISION OF TRAINING AND TECHNICAL ASSISTANCE TO, OR IN THE MANAGEMENT, 5 SUPERVISION AND COORDINATION OF, YOUTHBUILD PROGRAMS UNDER THIS SECTION. 6 ELIGIBLE PARTICIPANTS ARE YOUTH BETWEEN THE AGES OF SIXTEEN AND 4. 7 TWENTY-FOUR WHO ARE ECONOMICALLY DISADVANTAGED AS DEFINED IN 29 UNITED

8 STATES CODE 1503, AND WHO ARE PART OF ONE OF THE FOLLOWING GROUPS:

9 A. PERSONS WHO ARE NOT ATTENDING ANY SCHOOL AND HAVE NOT RECEIVED A 10 SECONDARY SCHOOL DIPLOMA OR ITS EQUIVALENT; OR

B. PERSONS CURRENTLY ENROLLED IN A TRADITIONAL OR ALTERNATIVE SCHOOL
SETTING OR A HSE/TASC (HIGH SCHOOL EQUIVALENCY/TEST ASSESSING SECONDARY
COMPLETION) PROGRAM AND WHO ARE IN DANGER OF DROPPING OUT OF SCHOOL; OR
C. VERY LOW-INCOME PERSONS WHOSE INCOMES ARE AT OR LESS THAN FIFTY
PERCENT OF THE AREA MEDIAN INCOME AREA, ADJUSTED FOR FAMILY SIZE, AS

16 ESTIMATED BY THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.

5. AN EXCEPTION MAY BE MADE FOR INDIVIDUALS NOT MEETING INCOME OR BEDUCATIONAL NEED REQUIREMENTS. NOT MORE THAN TWENTY-FIVE PERCENT OF THE PARTICIPANTS IN SUCH PROGRAM MAY BE INDIVIDUALS WHO DO NOT MEET THE REQUIREMENTS OF SUBDIVISION FOUR OF THIS SECTION, BUT WHO HAVE EDUCA-TIONAL NEEDS DESPITE THE ATTAINMENT OF A HIGH SCHOOL DIPLOMA.

6. PRIORITY IN THE AWARDING OF FUNDS UNDER THIS SECTION SHALL BE GIVEN TO APPLICANTS WITH EXPERIENCE IN OPERATING YOUTHBUILD PROGRAMS AND IMPLEMENTING THE YOUTHBUILD MODEL, INCLUDING BUT NOT LIMITED TO, HOUSING CONSTRUCTION SKILLS TRAINING, EDUCATION, LEADERSHIP DEVELOPMENT, LIFE SKILLS TRAINING, AND COUNSELING SERVICES. PRIORITY SHALL ALSO BE GIVEN TO THOSE WHO MEET THE PROGRAM STANDARDS OF YOUTHBUILD USA, INC.

ANY NOT-FOR-PROFIT PRIVATE AGENCIES, OR PUBLIC AGENCIES WITH EXPE-28 7. 29 RIENCE OPERATING A YOUTHBUILD PROGRAM OR WITH A PLAN TO INCUBATE A YOUTHBUILD PROGRAM UNTIL IT CAN BE ESTABLISHED AS A NOT-FOR-PROFIT 30 PRIVATE AGENCY ARE ELIGIBLE ENTITIES. ONLY NOT-FOR-PROFIT PRIVATE AGEN-31 32 CIES OR PUBLIC AGENCIES THAT ARE LICENSED AFFILIATES OF YOUTHBUILD USA, INC. OR CURRENTLY RECEIVE A DEPARTMENT OF LABOR YOUTHBUILD AWARD, 33 ARE ELIGIBLE TO USE THE TERM YOUTHBUILD OR ELIGIBLE TO APPLY FOR THESE 34 35 FUNDS.

36 8. THE COMMISSIONER SHALL REQUIRE THAT AN APPLICATION FOR YOUTHBUILD 37 FUNDS UNDER THIS SECTION CONTAIN AT MINIMUM:

A. A REQUEST FOR AN IMPLEMENTATION GRANT, SPECIFYING THE AMOUNT OF THE
 GRANT REQUESTED AND ITS PROPOSED USES;

B. A DESCRIPTION OF THE APPLICANT AND A STATEMENT OF ITS QUALIFICATIONS, INCLUDING A DESCRIPTION OF THE APPLICANT'S PAST EXPERIENCE
RUNNING A YOUTHBUILD PROGRAM, AND ITS EXPERIENCE WITH HOUSING REHABILITATION OR CONSTRUCTION AND WITH YOUTH AND YOUTH EDUCATION, YOUTH LEADERSHIP DEVELOPMENT AND WORK EXPERIENCE SKILLS TRAINING PROGRAMS, AND ITS
RELATIONSHIP WITH LOCAL UNIONS AND YOUTH APPRENTICESHIP PROGRAMS, AND
OTHER COMMUNITY GROUPS;

The sum of twenty million dollars (\$20,000,000) per year for a period of three years, or so much thereof as may be necessary, is hereby 52 appropriated to the education department from any moneys in the state 53 54 treasury in the general fund to the credit of the local assistance 55 account not otherwise appropriated for services and expenses of the education department and any other appropriate agency or department for 56
