- AN ACT to amend the insurance law, in relation to mandatory health insurance coverage for providing prosthetic devices

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is 2 amended by adding a new paragraph 30 to read as follows:

3 EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR (30) 4 COMPREHENSIVE TYPE COVERAGE SHALL INCLUDE COVERAGE EOUAL TO OR ABOVE 5 STANDARD OF COVERAGE FOR PROSTHETIC DEVICES. MEDICARE'S THIS SHALL 6 INCLUDE COVERAGE NOT ONLY FOR THE PROVISION OF A PROSTHETIC DEVICE 7 REQUIRED TO BE WORN OR USED BY A POLICY HOLDER BUT ALSO THE REPAIR OR 8 REPLACEMENT OF A PROSTHETIC DEVICE REQUIRED TO BE WORN OR USED BY Α 9 POLICY HOLDER. COVERAGE SHALL INCLUDE EXPENSES FOR ASSESSMENT, EVALU-ATION, TREATMENT, MANAGEMENT, AND FOLLOW-UP CARE. COVERAGE SHALL NOT BE 10 THE GROUND THAT IT IS FOR COSMETIC PURPOSES OR IS NOT FOR A 11 DENIED ON FUNCTIONAL DEFECT OR IMPAIRMENT. THE TERM "PROSTHETIC DEVICE" AS USED IN 12 13 THIS SECTION INCLUDES AN ARTIFICIAL LIMB OR ARTIFICIAL EYE BUT SHALL NOT 14 INCLUDE SHOES OR ANY OTHER ARTICLE CONSIDERED AS ORDINARY WEARING 15 APPAREL, WHETHER OR NOT SPECIALLY CONSTRUCTED.

1 S 2. Subsection (1) of section 3221 of the insurance law is amended by 2 adding a new paragraph 19 to read as follows:

3 (19) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR 4 COMPREHENSIVE TYPE COVERAGE SHALL INCLUDE COVERAGE EQUAL TO OR ABOVE 5 MEDICARE'S STANDARD OF COVERAGE FOR PROSTHETIC DEVICES. THIS SHALL INCLUDE COVERAGE NOT ONLY FOR THE PROVISION OF A PROSTHETIC DEVICE 6 7 REOUIRED TO BE WORN OR USED BY A POLICY HOLDER BUT ALSO THE REPAIR OR 8 REPLACEMENT OF A PROSTHETIC DEVICE REQUIRED TO BE WORN OR USED BY Α 9 POLICY HOLDER. 16 S 3. Section 4303 of the insurance law is amended by adding a new 17 subsection (oo) to read as follows:

(OO) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR 18 19 COMPREHENSIVE TYPE COVERAGE SHALL INCLUDE COVERAGE EQUAL TO OR ABOVE MEDICARE'S STANDARD OF COVERAGE FOR PROSTHETIC DEVICES. 20 SHALL THIS 21 INCLUDE COVERAGE NOT ONLY FOR THE PROVISION OF A PROSTHETIC DEVICE 22 REQUIRED TO BE WORN OR USED BY A POLICY HOLDER BUT ALSO THE REPAIR OR 23 REPLACEMENT OF A PROSTHETIC DEVICE REQUIRED TO BE WORN OR USED BY A POLICY HOLDER. COVERAGE SHALL INCLUDE EXPENSES FOR ASSESSMENT, 24 EVALU-25 TREATMENT, MANAGEMENT, AND FOLLOW-UP CARE. COVERAGE SHALL NOT BE ATION, 26 DENIED ON THE GROUND THAT IT IS FOR COSMETIC PURPOSES OR IS NOT FOR A FUNCTIONAL DEFECT OR IMPAIRMENT. THE TERM "PROSTHETIC DEVICE" AS USED IN 27 THIS SECTION INCLUDES AN ARTIFICIAL LIMB OR ARTIFICIAL EYE BUT SHALL NOT 28 29 INCLUDE SHOES OR ANY OTHER ARTICLE CONSIDERED AS ORDINARY WEARING APPAREL, WHETHER OR NOT SPECIALLY CONSTRUCTED. 30

31 S 4. This act shall take effect on the ninetieth day after it shall 32 have become a law and shall apply to policies and contracts issued, 33 renewed, modified, altered or amended on or after such effective date.
