AN ACT to amend the general municipal law, in relation to the calculation of expenses of members of the police department and other peace officers in attending police training schools

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 72-c of the general municipal law, as amended by  
2     section 1 of subpart C of part C of chapter 97 of the laws of 2011, is  
3     amended to read as follows:  
4     S 72-c. Expenses of members of the police department and other peace  
5     officers in attending police training schools. The board or body of a  
6     county, city, town or village authorized to appropriate and to raise  
7     money by taxation and to make payments therefrom, is hereby authorized,  
8     in its discretion, to appropriate and to raise money by taxation and to  
9     make payments from such moneys, for the annual expenses of the members  
10    of the police department of such municipal corporation in attending a  
11    police training school, as provided by the regulations of the depart-  
12    ment, either within such municipal corporation or elsewhere within the  
13    state; and for the payment of reasonable expenses of such members and

1 other police officers or peace officers of the municipality while going  
2 to, attending, and returning from any training school conducted by or  
3 under the auspices of the federal bureau of investigation, whether with-  
4 in or without the state. Notwithstanding any inconsistent provision of  
5 any general, special or local law to the contrary, whenever a member of  
6 the police department of a municipal corporation, EXCEPT A POLICE  
7 DEPARTMENT OF A MUNICIPAL CORPORATION HAVING A POPULATION OF ONE MILLION  
8 OR MORE, has attended a police training school, the expense of which was  
9 borne by such municipal corporation, terminates employment with such  
10 municipal corporation and commences employment with any other municipal  
11 corporation, EXCEPT A POLICE DEPARTMENT OF A MUNICIPAL CORPORATION  
12 HAVING A POPULATION OF ONE MILLION OR MORE, or employer county sheriff,  
13 such employer municipal corporation or employer county sheriff shall  
14 reimburse the prior employer municipal corporation, EXCEPT A POLICE  
15 DEPARTMENT OF A MUNICIPAL CORPORATION HAVING A POPULATION OF ONE MILLION  
16 OR MORE, for such expenses, including, salary, tuition, enrollment fees,  
17 books, and the cost of transportation to and from training school, as  
18 follows: on a pro rata basis, to be calculated by subtracting from the  
19 number of days in the three years following the date of the member's  
20 graduation from police training school, the number of days between the  
21 date of the member's graduation from training school and the date of the  
22 termination of employment with the municipal corporation which paid for  
23 such training, and multiplying the difference by the per diem cost of  
24 such expenses, to be calculated by dividing the total cost of such  
25 expenses by the number of days in the three years following the date of  
26 the member's graduation, if such change in employment occurs within  
27 three years of such member's graduation from police training school.  
28 Provided, however, the employer municipal corporation or employer county  
29 sheriff shall not be required to reimburse the prior employer municipal  
30 corporation for that portion of such expenses which is reimbursable by  
31 the member to the prior employer municipal corporation under the terms  
32 of an employment or labor agreement. Provided, further, however, the  
33 employer municipal corporation or employer county sheriff shall not be  
34 required to reimburse the prior employer municipal corporation for such  
35 basic training if such change in employment occurs after the expiration  
36 of the validity of the member's certificate attesting to the satisfac-  
37 tory completion of an approved municipal police basic training program.  
38 S 2. This act shall take effect immediately.
