AN ACT to amend the education law, in relation to instruction related to the prevention of suicide as an integral part of health education

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The education law is amended by adding a new section 804-e 2 to read as follows:
 - S 804-E. INSTRUCTION RELATED TO THE PREVENTION OF SUICIDE ALL SCHOOLS SHALL BE AUTHORIZED TO INCLUDE, AS AN INTEGRAL YOUTHS. 1. PART OF HEALTH EDUCATION, INSTRUCTION REGARDING THE PREVENTION OF SUICIDE AMONG YOUTHS.

- INSTRUCTION REGARDING THE PREVENTION OF SUICIDE MAY BE INCLUDED IN THE HEALTH EDUCATION PROVIDED FOR ALL SECONDARY SCHOOL PUPILS AND SHALL TAUGHT BY TEACHERS CERTIFIED IN HEALTH EDUCATION. RELATED COURSES IN THE SECONDARY SCHOOL CURRICULUM MAY BE TAUGHT IN A MANNER SUPPORTIVE HEALTH EDUCATION REGARDING THE PREVENTION OF SUICIDE AMONG YOUTHS. SUCH CURRICULUM SHALL INCLUDE INSTRUCTION RELATING TO THE SIGNS AND RESPONSES TO DEPRESSION AND THE RISKS OF SUICIDE AMONG YOUTHS.
- 14 3. THE COMMISSIONER SHALL PROMULGATE RULES AND REGULATIONS TO IDENTIFY 15 OR DEVELOP MATERIALS ON THE PREVENTION OF SUICIDE AMONG YOUTHS 16 WELFARE OF PUPILS AND THE COMMUNITY TO BE AVAILABLE IN SCHOOL DISTRICTS AND SHALL BE MADE AVAILABLE ON THE INTERNET WEBSITE OF 17 THEDEPARTMENT. TO MEET 18 THE CONTENTS MAY BE VARIED THE NEEDS OF PARTICULAR SCHOOL DISTRICTS, OR PORTIONS THEREOF, AND NEED NOT BE UNIFORM THROUGHOUT
