AN ACT to amend the social services law and the banking law, in relation to prohibiting automated teller machines or point of sale terminals in certain locations from accepting electronic benefit transfer cards for cash withdrawals

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The social services law is amended by adding a new section  
2     144-b to read as follows:  
3     S 144-B. PROHIBITION OF THE USE OF ELECTRONIC BENEFIT TRANSFER CARDS  
4     IN CERTAIN LOCATIONS. THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE  
5     SHALL INSURE THAT ELECTRONIC BENEFIT TRANSFER CARDS ISSUED BY AND  
6     THROUGH THE AGENCY TO FACILITATE THE DELIVERY OF ASSISTANCE MAY NOT BE  
7     USED TO ACCESS STATE-PROVIDED CASH BENEFITS FROM ANY AUTOMATED TELLER  
8     MACHINES OR POINT OF SALE TERMINALS IN THE FOLLOWING LOCATIONS: (A)  
9     GAMBLING ESTABLISHMENTS; (B) PSYCHICS; (C) BAIL BOND ESTABLISHMENTS; (D)  
10    BINGO HALLS; (E) CRUISE SHIPS; (F) TATTOO PARLORS; OR (G) ANY BUSINESS  
11    PROVIDING SERVICES THAT HAVE BEEN DEEMED INCONSISTENT WITH THE INTENT OF  
12    THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE.  
13    S 2. The banking law is amended by adding a new section 9-v to read as  
14    follows:  
15    S 9-V. PROHIBITION OF THE USE OF ELECTRONIC BENEFIT TRANSFER CARDS AT  
16    AUTOMATED TELLER MACHINES IN CERTAIN LOCATIONS. ELECTRONIC BENEFIT  
17    TRANSFER CARDS ISSUED BY THE STATE TO FACILITATE THE DELIVERY OF ASSIST-  
18    ANCE MAY NOT BE USED TO ACCESS STATE-PROVIDED CASH BENEFITS FROM ANY  
19    AUTOMATED TELLER MACHINES OR POINT OF SALE TERMINALS IN THE FOLLOWING
