AN ACT to amend the tax law, in relation to personal exemptions of resident individuals

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 616 of the tax law is amended by adding a new 2 subsection (c) to read as follows:

3 (C) ADDITIONAL EXEMPTION. IN ADDITION TO THE EXEMPTION PROVIDED FOR IN 4 SUBSECTION (A) OF THIS SECTION FOR TAXABLE YEARS BEGINNING AFTER DECEM-5 BER THIRTY-FIRST, TWO THOUSAND THIRTEEN, A RESIDENT INDIVIDUAL SHALL BE 6 ALLOWED AN ADDITIONAL NEW YORK EXEMPTION OF SIX HUNDRED FIFTY DOLLARS 7 FOR EACH DEPENDENT (AS DEFINED IN THIS SUBSECTION) WHO IS OF THE AGE OF 8 OR OLDER, WHOSE GROSS INCOME FOR THE CALENDAR YEAR IN WHICH SIXTY-FIVE 9 THE TAXABLE YEAR OF THE TAXPAYER BEGINS IS NOT MORE THAN FIFTEEN HUNDRED DOLLARS. FOR THE PURPOSES OF THIS SUBSECTION THE TERM "DEPENDENT" SHALL 10 MEAN ANY OF THE FOLLOWING INDIVIDUALS OVER ONE-HALF WHOSE SUPPORT, FOR 11 12 CALENDAR YEAR IN WHICH THE TAXABLE YEAR OF THE TAXPAYER BEGINS WAS THE RECEIVED FROM THE TAXPAYER: 13

(1) THE FATHER OR MOTHER OF THE TAXPAYER;

(2) A STEPFATHER OR STEPMOTHER OF THE TAXPAYER;

16 (3) AN INDIVIDUAL (OTHER THAN AN INDIVIDUAL WHO AT ANY TIME DURING THE
17 TAXABLE YEAR WAS THE SPOUSE) WHO FOR THE TAXABLE YEAR OF THE TAXPAYER,
18 HAS AS HIS PRINCIPAL PLACE OF ABODE THE HOME OF THE TAXPAYER AND IS A
19 MEMBER OF THE TAXPAYER'S HOUSEHOLD.

20 S 2. This act shall take effect immediately.
