- AN ACT to amend the education law, in relation to establishing under the direction of the state board of pharmacy a drug repository program to accept and dispense donated prescription drugs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 6831 2 to read as follows:

3 S 6831. REPOSITORY PROGRAM; ACCEPT AND DISPENSE DONATED PRESCRIPTION 4 DRUGS. 1. AS USED IN THIS SECTION: A. "HOSPITAL" HAS THE SAME MEANING AS 5 IN SUBDIVISION ONE OF SECTION TWENTY-EIGHT HUNDRED ONE OF THE PUBLIC 6 HEALTH LAW.

7 B. "NONPROFIT CLINIC" MEANS A CORPORATION AS DEFINED IN SUBPARAGRAPH 8 PARAGRAPH (A) OF SECTION ONE HUNDRED TWO OF THE NOT-FOR-PROFIT FIVE OF CORPORATION LAW, OR ANY CHARITABLE ORGANIZATION NOT ORGANIZED 9 AND NOT OPERATED FOR PROFIT, THAT PROVIDES HEALTH CARE SERVICES TO INDIGENT AND 10 UNINSURED PERSONS. "NONPROFIT CLINIC" SHALL NOT INCLUDE A HOSPITAL OR A 11 12 FACILITY AS DEFINED IN SUBDIVISION ONE OF SECTION TWENTY-EIGHT HUNDRED 13 ONE OF THE PUBLIC HEALTH LAW.

14 C. "PRESCRIPTION DRUG" MEANS ANY DRUG TO WHICH THE FOLLOWING APPLIES:

15 (1) UNDER THE FOOD, DRUG, AND COSMETIC ACT, 52 STAT. 1040 (1938), 21 16 U.S.C.A. 301, AS AMENDED, THE DRUG IS REQUIRED TO BEAR A LABEL CONTAIN-17 ING THE LEGEND, "CAUTION: FEDERAL LAW PROHIBITS DISPENSING WITHOUT 18 PRESCRIPTION" OR "CAUTION: FEDERAL LAW RESTRICTS THIS DRUG TO USE BY OR 19 ON THE ORDER OF A LICENSED VETERINARIAN" OR ANY SIMILAR RESTRICTIVE 20 STATEMENT, OR THE DRUG MAY BE DISPENSED ONLY UPON A PRESCRIPTION.

1 (2) UNDER THIS ARTICLE, THE DRUG MAY BE DISPENSED ONLY UPON A 2 PRESCRIPTION.

3 (3) DRUGS THAT CAN ONLY BE DISPENSED TO A PATIENT REGISTERED WITH THE 4 DRUG'S MANUFACTURER IN ACCORDANCE WITH FEDERAL FOOD AND DRUG ADMINIS-5 TRATION REQUIREMENTS MAY NOT BE ACCEPTED OR DISTRIBUTED UNDER THE 6 PROVISIONS OF THIS SECTION.

7 2. THE STATE BOARD OF PHARMACY SHALL ESTABLISH A DRUG REPOSITORY 8 PROGRAM TO ACCEPT AND DISPENSE PRESCRIPTION DRUGS DONATED FOR THE PURPOSE OF BEING DISPENSED TO INDIVIDUALS WHO ARE RESIDENTS OF THIS 9 10 STATE AND MEET ELIGIBILITY STANDARDS ESTABLISHED IN RULES AND REGU-LATIONS ADOPTED BY THE BOARD UNDER SUBDIVISION FIVE OF THIS SECTION. 11 ONLY PRESCRIPTION DRUGS IN THEIR ORIGINAL SEALED AND TAMPER-EVIDENT UNIT 12 DOSE PACKAGING SHALL BE ACCEPTED AND DISPENSED. THE PACKAGING SHALL BE 13 14 UNOPENED, EXCEPT THAT DRUGS PACKAGED IN SINGLE UNIT DOSES SHALL BE ACCEPTED AND DISPENSED WHEN THE OUTSIDE PACKAGING IS OPENED IF THE 15 16 SINGLE UNIT DOSE PACKAGING IS UNDISTURBED. PRESCRIPTION DRUGS DONATED BY INDIVIDUALS BEARING AN EXPIRATION DATE THAT IS LESS THAN SIX MONTHS FROM 17 THE DATE THE DRUG IS DONATED SHALL NOT BE ACCEPTED OR DISPENSED. A 18 19 PRESCRIPTION DRUG SHALL NOT BE ACCEPTED OR DISPENSED IF THERE IS REASON 20 TO BELIEVE THAT IT IS ADULTERATED AS DESCRIBED IN SECTION SIXTY-EIGHT 21 HUNDRED FIFTEEN OF THIS ARTICLE. SUBJECT TO THE LIMITATION SPECIFIED IN 22 THIS SUBDIVISION, UNUSED PRESCRIPTION DRUGS DISPENSED FOR PURPOSES OF THE MEDICAID PROGRAM MAY BE ACCEPTED AND DISPENSED UNDER THE DRUG REPOS-23 24 ITORY PROGRAM.

25 3. A. ANY PERSON, INCLUDING A DRUG MANUFACTURER OR ANY HEALTH CARE FACILITY MAY DONATE PRESCRIPTION DRUGS TO THE DRUG REPOSITORY PROGRAM. 26 27 THE DRUGS SHALL BE DONATED AT A PHARMACY, HOSPITAL OR NONPROFIT CLINIC THAT ELECTS TO PARTICIPATE IN THE DRUG REPOSITORY PROGRAM AND MEETS 28 CRITERIA FOR PARTICIPATION IN THE PROGRAM ESTABLISHED IN RULES AND REGU-29 30 LATIONS ADOPTED BY THE STATE BOARD OF PHARMACY UNDER SUBDIVISION FIVE OF THIS SECTION. PARTICIPATION IN THE PROGRAM BY PHARMACIES, HOSPITALS AND 31 32 NONPROFIT CLINICS IS VOLUNTARY. NOTHING IN THIS SECTION REQUIRES A PHAR-33 MACY, HOSPITAL OR NONPROFIT CLINIC TO PARTICIPATE IN THE PROGRAM.

B. A PHARMACY, HOSPITAL OR NONPROFIT CLINIC ELIGIBLE TO PARTICIPATE IN 34 35 THE PROGRAM SHALL DISPENSE PRESCRIPTION DRUGS DONATED UNDER THIS SECTION TO INDIVIDUALS WHO ARE RESIDENTS OF THIS STATE AND MEET THE ELIGIBILITY 36 STANDARDS ESTABLISHED IN RULES AND REGULATIONS ADOPTED BY THE BOARD 37 UNDER SUBDIVISION FIVE OF THIS SECTION OR TO OTHER GOVERNMENT ENTITIES 38 AND NONPROFIT PRIVATE ENTITIES TO BE DISPENSED TO INDIVIDUALS WHO MEET 39 40 THE ELIGIBILITY STANDARDS. A PRESCRIPTION DRUG SHALL BE DISPENSED ONLY PURSUANT TO A PRESCRIPTION ISSUED BY A LICENSED HEALTH PROFESSIONAL 41 AUTHORIZED TO PRESCRIBE DRUGS, AS DEFINED IN SECTION SIXTY-EIGHT HUNDRED 42 43 TWO OF THIS ARTICLE. A PHARMACY, HOSPITAL OR NONPROFIT CLINIC THAT ACCEPTS DONATED DRUGS SHALL COMPLY WITH ALL APPLICABLE FEDERAL LAWS AND 44 45 LAWS OF THIS STATE DEALING WITH STORAGE AND DISTRIBUTION OF DANGEROUS DRUGS AND SHALL INSPECT ALL PRESCRIPTION DRUGS PRIOR TO DISPENSING THEM 46 47 TO DETERMINE THAT SUCH DRUGS ARE NOT ADULTERATED. THE PHARMACY, HOSPITAL OR NONPROFIT CLINIC SHALL CHARGE INDIVIDUALS RECEIVING 48 DONATED 49 PRESCRIPTION DRUGS A HANDLING FEE ESTABLISHED IN ACCORDANCE WITH RULES 50 AND REGULATIONS ADOPTED BY THE BOARD UNDER SUBDIVISION FIVE OF THIS SECTION. PRESCRIPTION DRUGS DONATED TO THE REPOSITORY SHALL NOT BE 51 52 RESOLD.

4. A. AS USED IN THIS SECTION, "HEALTH CARE PROFESSIONAL" MEANS ANY OF THE FOLLOWING WHO PROVIDE MEDICAL, DENTAL OR OTHER HEALTH-RELATED DIAG-NOSIS, CARE OR TREATMENT: A. 3329

1 (1) INDIVIDUALS AUTHORIZED UNDER THIS TITLE TO PRACTICE MEDICINE AND 2 SURGERY OR PODIATRIC MEDICINE AND SURGERY;

3 (2) REGISTERED PROFESSIONAL NURSES AND LICENSED PRACTICAL NURSES
 4 LICENSED UNDER ARTICLE ONE HUNDRED THIRTY-NINE OF THIS TITLE;

5 (3) PHYSICIAN ASSISTANTS AUTHORIZED TO PRACTICE UNDER ARTICLE ONE 6 HUNDRED THIRTY-ONE-B OF THIS TITLE;

7 (4) DENTISTS AND DENTAL HYGIENISTS LICENSED UNDER ARTICLE ONE HUNDRED 8 THIRTY-THREE OF THIS TITLE;

9 (5) OPTOMETRISTS LICENSED UNDER ARTICLE ONE HUNDRED FORTY-THREE OF 10 THIS TITLE;

(6) PHARMACISTS LICENSED UNDER THIS ARTICLE.

12 STATE BOARD OF PHARMACY; THE COMMISSIONER OF HEALTH; ANY B. THE PERSON, INCLUDING A DRUG MANUFACTURER OR GOVERNMENT ENTITY THAT DONATES 13 14 PRESCRIPTION DRUGS TO THE REPOSITORY PROGRAM; ANY PHARMACY, HOSPITAL, 15 NONPROFIT CLINIC OR HEALTH CARE PROFESSIONAL THAT ACCEPTS OR DISPENSES 16 PRESCRIPTION DRUGS UNDER THE PROGRAM; AND ANY PHARMACY, HOSPITAL OR NONPROFIT CLINIC THAT EMPLOYS A HEALTH CARE PROFESSIONAL WHO, REASONABLY 17 AND IN GOOD FAITH, ACCEPTS OR DISPENSES PRESCRIPTION DRUGS UNDER THE 18 19 PROGRAM SHALL NOT BE SUBJECT TO ANY OF THE FOLLOWING FOR MATTERS RELATED DONATING, ACCEPTING OR DISPENSING PRESCRIPTION DRUGS UNDER THE 20 TO 21 PROGRAM: CRIMINAL PROSECUTION; LIABILITY IN TORT OR OTHER CIVIL ACTION 22 FOR INJURY, DEATH OR LOSS TO PERSON OR PROPERTY; OR PROFESSIONAL DISCI-23 PLINARY ACTION.

24 A DRUG MANUFACTURER, WHO ACTS REASONABLY AND IN GOOD FAITH, SHALL NOT 25 SUBJECT TO CRIMINAL PROSECUTION OR LIABILITY IN TORT OR OTHER CIVIL BE 26 ACTION FOR INJURY, DEATH OR LOSS TO PERSON OR PROPERTY FOR MATTERS RELATED TO THE DONATION, ACCEPTANCE OR DISPENSING OF A PRESCRIPTION DRUG 27 28 MANUFACTURED BY THE DRUG MANUFACTURER THAT IS DONATED BY ANY PERSON 29 UNDER THE PROGRAM, INCLUDING BUT NOT LIMITED TO LIABILITY FOR FAILURE TO TRANSFER OR COMMUNICATE PRODUCT OR CONSUMER INFORMATION OR THE EXPIRA-30 31 TION DATE OF THE DONATED PRESCRIPTION DRUG.

5. IN CONSULTATION WITH THE COMMISSIONER OF HEALTH, THE STATE BOARD OF
 PHARMACY SHALL ADOPT RULES AND REGULATIONS GOVERNING THE DRUG REPOSITORY
 PROGRAM THAT ESTABLISH ALL OF THE FOLLOWING:

35 A. ELIGIBILITY CRITERIA FOR PHARMACIES, HOSPITALS AND NONPROFIT CLIN-36 ICS TO RECEIVE AND DISPENSE DONATED PRESCRIPTION DRUGS UNDER THE 37 PROGRAM;

B. STANDARDS AND PROCEDURES FOR ACCEPTING, SAFELY STORING AND DISPENS ING DONATED PRESCRIPTION DRUGS;

40 C. STANDARDS AND PROCEDURES FOR INSPECTING DONATED PRESCRIPTION DRUGS 41 TO DETERMINE THAT THE ORIGINAL UNIT DOSE PACKAGING IS SEALED AND 42 TAMPER-EVIDENT AND THAT THE DRUGS ARE UNADULTERATED, SAFE AND SUITABLE 43 FOR DISPENSING;

44 D. ELIGIBILITY STANDARDS BASED ON ECONOMIC NEED FOR INDIVIDUALS TO 45 RECEIVE PRESCRIPTION DRUGS;

E. A MEANS, SUCH AS AN IDENTIFICATION CARD, BY WHICH AN INDIVIDUAL WHO
IS ELIGIBLE TO RECEIVE DONATED PRESCRIPTION DRUGS SHALL DEMONSTRATE
ELIGIBILITY TO THE PHARMACY, HOSPITAL OR NONPROFIT CLINIC DISPENSING THE
DRUGS;

50 F. A FORM THAT AN INDIVIDUAL RECEIVING A PRESCRIPTION DRUG FROM THE 51 REPOSITORY SHALL SIGN BEFORE RECEIVING THE DRUG TO CONFIRM THAT THE 52 INDIVIDUAL UNDERSTANDS THE IMMUNITY PROVISIONS OF THE PROGRAM;

53 G. A FORMULA TO DETERMINE THE AMOUNT OF A HANDLING FEE THAT PHARMA-54 CIES, HOSPITALS AND NONPROFIT CLINICS SHALL CHARGE TO PRESCRIPTION DRUG 55 RECIPIENTS TO COVER RESTOCKING AND DISPENSING COSTS;

H. IN ADDITION, FOR PRESCRIPTION DRUGS DONATED TO THE REPOSITORY BY 1 2 INDIVIDUALS: 3 (1) A LIST OF PRESCRIPTION DRUGS, ARRANGED EITHER BY CATEGORY OR BY 4 INDIVIDUAL DRUG, THAT THE REPOSITORY SHALL ACCEPT FROM INDIVIDUALS; 5 (2) A LIST OF PRESCRIPTION DRUGS, ARRANGED EITHER BY CATEGORY OR BY INDIVIDUAL DRUG, THAT THE REPOSITORY SHALL NOT ACCEPT FROM INDIVIDUALS. 6 7 THE LIST SHALL INCLUDE BUT NOT BE LIMITED TO, A STATEMENT AS TO WHY THEDRUG IS INELIGIBLE FOR DONATION. 8 (3) A FORM EACH DONOR SHALL SIGN STATING THAT THE DONOR IS THE OWNER 9 10 OF THE PRESCRIPTION DRUGS AND INTENDS TO VOLUNTARILY DONATE SUCH DRUGS TO THE REPOSITORY. 11 12 ADDITION, FOR PRESCRIPTION DRUGS DONATED TO THE REPOSITORY BY I. IN 13 HEALTH CARE FACILITIES: 14 (1) A LIST OF PRESCRIPTION DRUGS, ARRANGED EITHER BY CATEGORY OR ΒY 15 INDIVIDUAL DRUG, THAT THE REPOSITORY SHALL ACCEPT FROM HEALTH CARE FACILITIES; 16 17 (2) A LIST OF PRESCRIPTION DRUGS, ARRANGED EITHER BY CATEGORY OR BY INDIVIDUAL DRUG, THAT THE REPOSITORY SHALL NOT ACCEPT FROM HEALTH CARE 18 19 FACILITIES. THE LIST SHALL INCLUDE A STATEMENT AS TO WHY SUCH DRUG IS INELIGIBLE FOR DONATION. 20 21 J. ANY OTHER STANDARDS AND PROCEDURES THE BOARD CONSIDERS APPROPRIATE. 22 S 2. This act shall take effect on the one hundred eightieth day after 23 shall have become a law. Effective immediately, the addition, amendit ment and/or repeal of any rule or regulation necessary for the implemen-24 25 tation of this act on its effective date is authorized to be made on or 26 before such effective date.
