AN ACT to amend the criminal procedure law and the penal law, in relation to establishing new criminal discovery rules; and to repeal article 240 of the criminal procedure law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Article 240 of the criminal procedure law is REPEALED.  
2 S 2. The criminal procedure law is amended by adding a new article 245

1 SECTION 245.20 OF THIS ARTICLE AS SOON AS PRACTICABLE BUT NOT LATER THAN  
2 FIFTEEN CALENDAR DAYS AFTER THE DEFENDANT'S ARRAIGNMENT ON AN INDICT-  
3 MENT, SUPERIOR COURT INFORMATION, PROSECUTOR'S INFORMATION, INFORMATION,  
4 OR SIMPLIFIED INFORMATION CHARGING A MISDEMEANOR, EXCEPT THAT PORTIONS  
5 OF MATERIALS CLAIMED TO BE NON-DISCOVERABLE MAY BE WITHHELD PENDING A  
6 DETERMINATION AND RULING OF THE COURT UNDER SECTION 245.70 OF THIS ARTI-  
7 CLE; BUT THE DEFENDANT MUST BE NOTIFIED IN WRITING THAT INFORMATION HAS

13 RIALS UNDER PARAGRAPH (A) OF SUBDIVISION ONE OF SECTION 245.20 OF THIS  
14 ARTICLE TO ANY DEFENDANT WHO HAS BEEN ARRAIGNED IN A LOCAL CRIMINAL  
15 COURT UPON A CURRENTLY UNDISPOSED OF FELONY COMPLAINT CHARGING AN  
16 OFFENSE WHICH IS A SUBJECT OF A PROSPECTIVE OR PENDING GRAND JURY  
17 PROCEEDING, NO LATER THAN FORTY-EIGHT HOURS BEFORE THE TIME SCHEDULED  
18 FOR THE DEFENDANT TO TESTIFY AT A GRAND JURY PROCEEDING PURSUANT TO  
19 SUBDIVISION FIVE OF SECTION 190.50 OF THIS CHAPTER.

20 2. DISCLOSURE PRIOR TO A GUILTY PLEA DEADLINE. IF THE PROSECUTION HAS  
21 IMPOSED A GUILTY PLEA DEADLINE, BUT DOES NOT PROVIDE THE DEFENDANT WITH  
22 MATERIAL DISCLOSURE LISTED IN SUBDIVISION ONE OF SECTION 245.20 OF THIS  
23 ARTICLE AT LEAST THIRTY CALENDAR DAYS BEFORE THE GUILTY PLEA DEADLINE,  
24 THE COURT, UPON MOTION OF THE DEFENDANT, SHALL CONSIDER THE IMPACT OF  
25 THE FAILURE TO PROVIDE SUCH DISCLOSURE ON THE DEFENDANT'S DECISION TO  
26 ACCEPT OR REJECT A GUILTY PLEA OFFER. IF THE COURT DETERMINES THAT THE  
27 PROSECUTOR'S FAILURE TO PROVIDE SUCH DISCLOSURE MATERIALLY AFFECTED THE  
28 DEFENDANT'S DECISION TO REJECT A GUILTY PLEA OFFER AND THE PROSECUTOR  
29 DECLINES TO REINSTATE THAT LAPSED GUILTY PLEA OFFER, THE PRESUMPTIVE  
30 MINIMUM REMEDY OR SANCTION SHALL BE PRECLUSION FROM ADMISSION AT TRIAL  
31 OF ANY EVIDENCE NOT DISCLOSED AT LEAST THIRTY CALENDAR DAYS BEFORE THE  
32 DEADLINE. IF THE COURT DETERMINES, UPON MOTION OF THE DEFENDANT MADE  
33 PRIOR TO SENTENCING, THAT THE PROSECUTOR'S FAILURE TO PROVIDE DISCLOSURE  
34 LISTED IN PARAGRAPH (J) OF SUBDIVISION ONE OF SECTION 245.20 OF THIS  
35 ARTICLE MATERIALLY AFFECTED THE DEFENDANT'S DECISION TO ACCEPT A GUILTY

48 1. INITIAL DISCOVERY FOR THE DEFENDANT. THE PROSECUTION SHALL DISCLOSE  
49 TO THE DEFENDANT, AND PERMIT THE DEFENDANT TO DISCOVER, INSPECT, COPY OR  
50 PHOTOGRAPH, EACH OF THE FOLLOWING ITEMS AND INFORMATION WHEN IT IS IN  
51 THE POSSESSION, CUSTODY OR CONTROL OF THE PROSECUTION OR PERSONS UNDER  
52 THE PROSECUTION'S DIRECTION OR CONTROL:

53 (A) ALL WRITTEN AND RECORDED STATEMENTS, AND THE SUBSTANCE OF ALL ORAL  
54 STATEMENTS, MADE BY THE DEFENDANT OR A CO-DEFENDANT WHICH RELATE TO THE  
55 SUBJECT MATTER OF THE CASE OR ARE OTHERWISE RELEVANT;

1 (B) ALL TRANSCRIPTS OF THE TESTIMONY OF A PERSON WHO HAS TESTIFIED  
2 BEFORE ANY GRAND JURY WHEN THE TESTIMONY RELATES TO THE SUBJECT MATTER  
3 OF THE CASE OR IS OTHERWISE RELEVANT;

4 (C) THE NAMES, KNOWN ALIASES, ADDRESSES AND BIRTH DATES OF ALL  
5 PERSONS, OTHER THAN LAW ENFORCEMENT PERSONNEL, WHOM THE PROSECUTOR KNOWS  
6 TO HAVE EVIDENCE OR INFORMATION RELEVANT TO ANY OFFENSE CHARGED OR TO A  
7 POTENTIAL DEFENSE THERETO, INCLUDING A DESIGNATION BY THE PROSECUTOR AS  
8 TO WHICH OF THOSE PERSONS MAY BE CALLED AS WITNESSES;

9 (D) THE NAME, RANK, SHIELD NUMBER AND BUSINESS ADDRESS OF ALL LAW  
10 ENFORCEMENT PERSONNEL WHOM THE PROSECUTOR KNOWS TO HAVE EVIDENCE OR  
11 INFORMATION RELEVANT TO ANY OFFENSE CHARGED OR TO A POTENTIAL DEFENSE  
12 THERETO;

13 (E) ALL STATEMENTS, WRITTEN OR RECORDED OR SUMMARIZED IN ANY WRITING  
14 OR RECORDING, WHICH RELATE TO THE SUBJECT MATTER OF THE CASE OR ARE  
15 OTHERWISE RELEVANT AND WERE MADE BY PERSONS WHOM THE PROSECUTOR KNOWS TO  
16 HAVE EVIDENCE OR INFORMATION RELEVANT TO ANY OFFENSE CHARGED OR TO A  
17 POTENTIAL DEFENSE THERETO;

18 (F) INTENDED EXPERT OPINION EVIDENCE, INCLUDING THE NAME, BUSINESS  
19 ADDRESS, CURRENT CURRICULUM VITAE, AND A LIST OF PUBLICATIONS OF EACH  
20 INTENDED EXPERT WITNESS, AND ALL REPORTS PREPARED BY THE EXPERT THAT  
21 PERTAIN TO THE CASE, OR IF NO REPORT IS PREPARED, A WRITTEN STATEMENT OF  
22 THE FACTS AND OPINIONS TO WHICH THE EXPERT IS EXPECTED TO TESTIFY AND A  
23 SUMMARY OF THE GROUNDS FOR EACH OPINION. THIS SUBDIVISION DOES NOT ALTER  
24 OR IN ANY WAY AFFECT THE PROCEDURES, OBLIGATIONS OR RIGHTS SET FORTH IN  
25 SECTION 250.10 OF THIS TITLE. IF IN THE EXERCISE OF REASONABLE DILIGENCE  
26 THIS INFORMATION IS UNAVAILABLE FOR DISCLOSURE WITHIN THE TIME PERIOD  
27 SPECIFIED IN SUBDIVISION ONE OF SECTION 245.10 OF THIS ARTICLE, THAT  
28 PERIOD SHALL BE STAYED WITHOUT NEED FOR A MOTION PURSUANT TO SECTION  
29 245.75 OF THIS ARTICLE; EXCEPT THAT THE DISCLOSURE SHALL BE MADE AS SOON  
30 AS PRACTICABLE AND NOT LATER THAN SIXTY CALENDAR DAYS BEFORE TRIAL,  
31 UNLESS AN ORDER IS OBTAINED PURSUANT TO SECTION 245.75 OF THIS ARTICLE;

32 (G) ALL POLICE REPORTS, LAW ENFORCEMENT AGENCY REPORTS, POLICE OFFICER  
33 MEMO BOOK ENTRIES AND LOG ENTRIES AND NOTES, INTENDED EXHIBITS, TAPES  
34 AND OTHER ELECTRONIC RECORDINGS, PHOTOGRAPHS, DRAWINGS, AND TANGIBLE  
35 OBJECTS WHICH RELATE TO THE SUBJECT MATTER OF THE CASE OR ARE OTHERWISE  
36 RELEVANT, INCLUDING ANY PHOTOGRAPH, PHOTOCOPY OR REPRODUCTION MADE BY OR  
37 AT THE DIRECTION OF LAW ENFORCEMENT PERSONNEL OF ANY PROPERTY PRIOR TO  
38 ITS RELEASE PURSUANT TO SECTION 450.10 OF THE PENAL LAW;

39 (H) ALL REPORTS, DOCUMENTS, RESULTS AND INFORMATION CONCERNING SCIEN-  
40 TIFIC TESTS AND EXPERIMENTS AND COMPARISONS, AND PHYSICAL AND MENTAL  
41 EXAMINATIONS OF ANY PERSON, WHICH RELATE TO THE SUBJECT MATTER OF THE  
42 CASE OR ARE OTHERWISE RELEVANT;

43 (I) ALL TANGIBLE OBJECTS OBTAINED FROM OR ALLEGEDLY BELONGING TO THE  
44 DEFENDANT OR A CO-DEFENDANT, INCLUDING A DESIGNATION BY THE PROSECUTOR  
45 AS TO WHICH TANGIBLE OBJECTS WERE PHYSICALLY OR CONSTRUCTIVELY POSSESSED  
46 BY THE DEFENDANT AND WERE RECOVERED DURING A SEARCH OR SEIZURE BY A  
47 POLICE OFFICER OR OTHER PUBLIC SERVANT OR AN AGENT THEREOF, AND WHICH  
48 TANGIBLE OBJECTS WERE RECOVERED BY A POLICE OFFICER OR OTHER PUBLIC  
49 SERVANT OR AN AGENT THEREOF AFTER ALLEGEDLY BEING ABANDONED BY THE  
50 DEFENDANT. IF THE PROSECUTION INTENDS TO PROVE THE DEFENDANT'S  
51 POSSESSION OF ANY TANGIBLE OBJECTS SOLELY BY MEANS OF A STATUTORY  
52 PRESUMPTION OF POSSESSION UNDER SECTION 220.25 OR 265.15 OF THE PENAL  
53 LAW OR ANOTHER PROVISION, IT SHALL ALSO DESIGNATE THAT INTENTION AS TO  
54 EACH SUCH OBJECT. IN ADDITION THE PROSECUTOR SHALL DESIGNATE THE  
55 LOCATIONS FROM WHICH ALL TANGIBLE OBJECTS WERE RECOVERED;

1 (J) ALL EVIDENCE AND INFORMATION WHICH TENDS TO NEGATE THE DEFENDANT'S  
2 GUILT OR TO MITIGATE THE DEFENDANT'S CULPABILITY AS TO A CHARGED  
3 OFFENSE, OR WHICH TENDS TO SUPPORT A POTENTIAL DEFENSE THERETO, OR WHICH  
4 TENDS TO SUPPORT A MOTION TO SUPPRESS EVIDENCE ON CONSTITUTIONAL  
5 GROUNDS, OR WHICH WOULD TEND TO REDUCE THE PUNISHMENT OF THE DEFENDANT.

6 (I) SUCH EVIDENCE OR INFORMATION INCLUDES BUT IS NOT LIMITED TO: AN  
7 OVERT OR TACIT LENIENCY OFFER OR DEAL WITH A POTENTIAL PROSECUTION  
8 WITNESS OR AN INFORMANT; A POTENTIAL PROSECUTION WITNESS'S OR AN  
9 INFORMANT'S PRIOR INCONSISTENT STATEMENTS; INFORMATION INDICATING A  
10 POTENTIAL PROSECUTION WITNESS'S OR AN INFORMANT'S POSSIBLE BIAS, INTER-  
11 EST, HOSTILITY, OR REASONS TO FABRICATE; INFORMATION THAT TENDS TO  
12 UNDERCUT THE BELIEVABILITY OF A POTENTIAL PROSECUTION WITNESS'S OR AN  
13 INFORMANT'S FACTUAL ACCOUNT; PRIOR CONDUCT, MISCONDUCT AND CRIMINAL ACTS  
14 THAT TEND TO UNDERCUT THE CREDIBILITY OF A POTENTIAL PROSECUTION WITNESS  
15 OR AN INFORMANT; AND INFORMATION THAT TENDS TO UNDERCUT THE PROOF OF AN  
16 ELEMENT OF A CHARGED OFFENSE OR THAT OTHERWISE TENDS TO INDICATE THE  
17 DEFENDANT MAY NOT BE GUILTY.

18 (II) DISCLOSURE IS REQUIRED EVEN IF THE PROSECUTION DOUBTS THE BELIEV-  
19 ABILITY OR USEFULNESS TO THE DEFENDANT OF THE EVIDENCE OR INFORMATION,  
20 OR BELIEVES IT CAN BE RECONCILED WITH THE PROSECUTION'S OTHER EVIDENCE;  
21 OR IF IT HAS BOTH AN INCUHPATORY AND AN EXCULPATORY EFFECT; OR IF IT  
22 RELATES TO A POTENTIAL DEFENSE DIFFERENT FROM THAT WHICH HAS BEEN  
23 ANNOUNCED OR IS BEING PURSUED; OR IF IT HAS NOT BEEN MEMORIALIZED OR  
24 RECORDED IN TANGIBLE FORM; OR IF IT IS NOT ADMISSIBLE AS EVIDENCE IN ITS  
25 PRESENT FORM; OR IF IT IS KNOWN TO THE DEFENDANT; OR IF IT RELATES TO A  
26 PERSON WHOM THE PROSECUTION DOES NOT INTEND TO CALL AT TRIAL BUT WHO  
27 POSSESSES EXCULPATORY INFORMATION;

28 (K) A SUMMARY OF ALL CORPOREAL OR NON-CORPOREAL OR VOICE IDENTIFICA-  
29 TION PROCEDURES, INCLUDING NOT ONLY PROCEDURES IN WHICH AN EYEWITNESS  
30 IDENTIFIED THE DEFENDANT BUT ALSO PROCEDURES IN WHICH AN EYEWITNESS DID  
31 NOT IDENTIFY THE DEFENDANT WHEN THE OPPORTUNITY FOR SUCH IDENTIFICATION  
32 EXISTED. THE SUMMARY SHALL INCLUDE:

33 (I) THE DATE, TIME, LOCATION, TYPE, AND RESULT OF EACH PROCEDURE;

34 (II) THE NAMES OF ALL PERSONS PRESENT AT EACH PROCEDURE IF KNOWN TO  
35 LAW ENFORCEMENT;

36 (III) THE NAME AND ADDRESS OF EACH EYEWITNESS AT EACH PROCEDURE;

37 (IV) THE NUMBER AND SOURCE OF ALL PHOTOGRAPHS OR LINEUP PARTICIPANTS  
38 USED IN EACH PROCEDURE;

39 (V) A COPY OF ALL PHOTOGRAPHS, PHOTOGRAPHIC ARRAYS, AND PHOTOGRAPHS  
40 TAKEN OF ALL LINEUPS VIEWED BY AN EYEWITNESS;

41 (VI) THE DESCRIPTIONS OF SUSPECTS ENTERED INTO AN ELECTRONIC OR  
42 COMPUTER PHOTOGRAPHIC IDENTIFICATION SYSTEM, AND A SAVED COLLECTION OF  
43 THE PHOTOGRAPHIC IMAGES GENERATED BY EACH DESCRIPTION AND VIEWED BY EACH  
44 EYEWITNESS;

45 (VII) WHETHER THE PROCEDURE WAS SIMULTANEOUS OR SEQUENTIAL;

46 (VIII) ALL STATEMENTS MADE IN THE PRESENCE OF OR BY EACH EYEWITNESS  
47 THAT ARE RELEVANT TO THE ISSUE OF IDENTITY OR TO THE FAIRNESS OR ACCURA-  
48 CY OF THE PROCEDURE, INCLUDING THE WORDS USED BY AN EYEWITNESS IN MAKING  
49 ANY IDENTIFICATION AND ANY WORDS DESCRIBING HIS OR HER CERTAINTY OR  
50 UNCERTAINTY IN AN IDENTIFICATION AT THE TIME IT WAS MADE;

51 (IX) ALL STATEMENTS MADE BY EACH EYEWITNESS REGARDING THE ROLE IN THE  
52 CHARGED OFFENSE OF A PERSON IDENTIFIED AND ANY OTHER RELATIONSHIP  
53 BETWEEN THEM;

54 (X) WHETHER THE EYEWITNESS SELECTED A DIFFERENT PERSON AS THE PERPE-  
55 TRATOR OR INDICATED A BELIEF THAT HE OR SHE COULD NOT IDENTIFY THE  
56 PERPETRATOR;

1 (XI) WHETHER BEFORE THE PROCEDURE THE EYEWITNESS WAS INSTRUCTED THAT  
2 THE PERPETRATOR MIGHT OR MIGHT NOT BE PRESENT;

3 (XII) WHETHER THE ADMINISTRATOR OF EACH PROCEDURE KNEW WHICH PERSON  
4 WAS THE SUSPECT, AND WHETHER, BEFORE THE PROCEDURE, THE EYEWITNESS WAS  
5 INSTRUCTED THAT THE ADMINISTRATOR DID NOT KNOW WHICH PERSON WAS THE  
6 SUSPECT; AND

7 (XIII) IF THE PROSECUTION POSSESSES INFORMATION THAT AN EYEWITNESS  
8 MADE A CORPOREAL OR NON-CORPOREAL OR VOICE OBSERVATION OF THE DEFENDANT  
9 ON ANY OTHER OCCASION AFTER THE TIME OF THE CHARGED OFFENSE BUT BEFORE  
10 TRIAL, REGARDLESS OF THE INVOLVEMENT OR LACK OF INVOLVEMENT OF A POLICE  
11 OFFICER OR OTHER PUBLIC SERVANT IN THAT OBSERVATION, IT SHALL ALSO  
12 DISCLOSE THAT INFORMATION;

13 (L) A SUMMARY OF ALL PROMISES, REWARDS AND INDUCEMENTS MADE TO PERSONS  
14 WHO MAY BE CALLED AS WITNESSES, AS WELL AS REQUESTS FOR CONSIDERATION BY  
15 PERSONS WHO MAY BE CALLED AS WITNESSES, AND COPIES OF ALL DOCUMENTS  
16 RELEVANT TO A PROMISE, REWARD AND INDUCEMENT;

17 (M) WHETHER THE PROSECUTION HAS ANY EVIDENCE OR INFORMATION THAT HAS  
18 BEEN PROVIDED BY A CONFIDENTIAL INFORMANT OR A JAILHOUSE INFORMANT WHICH  
19 RELATES TO THE SUBJECT MATTER OF THE CASE OR IS OTHERWISE RELEVANT;

20 (N) WHETHER A SEARCH WARRANT HAS BEEN EXECUTED AND ALL DOCUMENTS  
21 RELATING THERETO, INCLUDING BUT NOT LIMITED TO THE WARRANT, THE WARRANT  
22 APPLICATION, ALL SUPPORTING AFFIDAVITS, A POLICE INVENTORY OF ALL PROP-  
23 erty SEIZED UNDER THE WARRANT, AND A TRANSCRIPT OF ALL TESTIMONY OR  
24 OTHER ORAL COMMUNICATIONS OFFERED IN SUPPORT OF THE WARRANT APPLICATION;

25 (O) WHETHER THERE HAS BEEN ANY ELECTRONIC SURVEILLANCE, INCLUDING BUT  
26 NOT LIMITED TO WIRETAPPING OR VIDEO SURVEILLANCE, OF A RESIDENCE OR  
27 BUSINESS OR TELEPHONE OR COMPUTER OR OTHER ELECTRONIC OR DIGITAL DEVICE  
28 OF THE DEFENDANT, OR OF CONVERSATIONS TO WHICH THE DEFENDANT OR A CO-DE-  
29 FENDANT WAS A PARTY, AND ALL RECORDINGS, TRANSCRIPTS, DOCUMENTS,  
30 WARRANTS AND WARRANT APPLICATION MATERIALS RELATING THERETO;

31 (P) THE APPROXIMATE DATE, TIME AND PLACE OF THE OFFENSE OR OFFENSES  
32 CHARGED AND OF THE DEFENDANT'S SEIZURE AND ARREST;

12 MAY MAKE A FURTHER ORDER FOR DISCOVERY, GRANT A CONTINUANCE, ORDER THAT

10 2. A child witness should be declared vulnerable when the court, in  
11 accordance with the provisions of this section, determines by clear and  
12 convincing evidence that the child witness would suffer serious mental  
13 or emotional harm that would substantially impair the child witness'  
14 ability to communicate with the finder of fact without the use of live,  
15 two-way closed-circuit television.

16 3. A motion pursuant to subdivision one of this section must be made  
17 in writing at least eight days before the commencement of trial or other  
18 criminal proceeding upon reasonable notice to the other party and with

20 4. The motion papers must state the basis for the motion and must

5 ing the incident has been made by or on behalf of the defendant.

6 (h) A threat, express or implied, of the incarceration of a parent or  
7 guardian of the child witness, the removal of the child witness from the

14 physical violence directed at such witness or to a third person by or on

16 (j) The defendant, at the time of the inquiry, (i) is living in the  
17 same household with the child witness, (ii) has ready access to the  
18 child witness or (iii) is providing substantial financial support for  
19 the child witness.

20 (k) The child witness has previously been the victim of an offense  
21 defined in article one hundred thirty of the penal law or incest as  
22 defined in section 255.25, 255.26 or 255.27 of such law.

23 (l) According to expert testimony, the child witness would be partic-  
24 ularly [suceptible] SUSCEPTIBLE to psychological harm if required to  
25 testify in open court or in the physical presence of the defendant.

26 11. Irrespective of whether a motion was made pursuant to subdivision  
27 one of this section, the court, at the request of either party or on its  
28 own motion, may decide that a child witness may be vulnerable based on  
29 its own observations that a child witness who has been called to testify  
30 at a criminal proceeding is suffering severe mental or emotional harm  
31 and therefore is physically or mentally unable to testify or to continue  
32 to testify in open court or in the physical presence of the defendant  
33 and that the use of live, two-way closed-circuit television is necessary  
34 to enable the child witness to testify. If the court so decides, it must

21 SUCH A COMPARISON AND (B) IF SUCH COMPARISON HAD BEEN CONDUCTED, AND IF  
22 THE RESULTS HAD BEEN ADMITTED IN THE TRIAL RESULTING IN THE JUDGMENT, A  
23 REASONABLE PROBABILITY EXISTS THAT THE VERDICT WOULD HAVE BEEN MORE  
24 FAVORABLE TO THE DEFENDANT, OR IN A CASE INVOLVING A PLEA OF GUILTY, IF  
25 THE RESULTS HAD BEEN AVAILABLE TO THE DEFENDANT PRIOR TO THE PLEA, A  
26 REASONABLE PROBABILITY EXISTS THAT THE CONVICTION WOULD NOT HAVE  
27 RESULTED.

28 S 9. Section 460.80 of the penal law, as added by chapter 516 of the  
29 laws of 1986, is amended to read as follows:

30 S 460.80 Court ordered disclosure.

31 Notwithstanding the provisions of article two hundred [forty]  
32 FORTY-FIVE of the criminal procedure law, when forfeiture is sought  
33 pursuant to section 460.30 of this [chapter] ARTICLE, the court may  
34 order discovery of any property not otherwise disclosed which is materi-  
35 al and reasonably necessary for preparation by the defendant with  
36 respect to the forfeiture proceeding pursuant to such section. The court  
37 may issue a protective order denying, limiting, conditioning, delaying  
38 or regulating such discovery where a danger to the integrity of physical  
39 evidence or a substantial risk of physical harm, intimidation, economic  
40 reprisal, bribery or unjustified annoyance or embarrassment to any  
41 person or an adverse effect upon the legitimate needs of law enforce-  
42 ment, including the protection of the confidentiality of informants, or  
43 any other factor or set of factors outweighs the usefulness of the  
44 discovery.

45 S 10. Subdivision 5 of section 480.10 of the penal law, as added by  
46 chapter 655 of the laws of 1990, is amended to read as follows:

47 5. In addition to information required to be disclosed pursuant to  
48 article two hundred [forty] FORTY-FIVE of the criminal procedure law,  
49 when forfeiture is sought pursuant to this article, and following the  
50 defendant's arraignment on the special forfeiture information, the court  
51 shall order discovery of any information not otherwise disclosed which  
52 is material and reasonably necessary for preparation by the defendant  
53 with respect to a forfeiture proceeding brought pursuant to this arti-  
54 cle. Such material shall include those portions of the grand jury  
55 minutes and such other information which pertain solely to the special  
56 forfeiture information and shall not include information which pertains

1 to the criminal charges. Upon application of the prosecutor, the court  
2 may issue a protective order pursuant to section [240.40] 245.70 of the  
3 criminal procedure law with respect to any information required to be  
4 disclosed pursuant to this subdivision.

5 S 11. This act shall take effect on the ninetieth day after it shall  
6 have become a law; provided, however, the amendments to section 65.20 of  
7 the criminal procedure law made by section three of this act shall not  
8 affect the repeal of such section and shall be deemed repealed there-  
9 with.
