CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to article 5 of the constitution, relating to the filling of vacancies in the offices of comptroller and attorney-general

Section 1. Resolved (if the Senate concur), That section 1 of article 5 of the constitution be amended to read as follows:

Section 1. The comptroller and attorney-general shall be chosen at the 3 same general election as the governor and hold office for the same term, 4 shall possess the qualifications provided in section 2 of article 5 and 6 IV. The legislature shall provide for filling vacancies in the office of 7 comptroller and of attorney-general UNTIL THE NEXT GENERAL ELECTION 8 HAPPENING NOT LESS THAN THREE MONTHS AFTER THE OFFICE SHALL HAVE BECOME 9 VACANT, AT WHICH TIME A COMPTROLLER OR ATTORNEY-GENERAL SHALL BE ELECTED TO SERVE THE REMAINDER OF THE TERM. [No election of a comptroller or an attorney-general shall be had except at the time of electing a gover-10 11 12 IN CASE THE COMPTROLLER-ELECT OR ATTORNEY-GENERAL-ELECT SHALL nor.l 13 DECLINE TO SERVE OR SHALL DIE, THE LEGISLATURE SHALL PROVIDE FOR FILLING 14 THE VACANCY UNTIL THE NEXT GENERAL ELECTION. The comptroller shall be 15 required: (1) to audit all vouchers before payment and all official accounts; (2) to audit the accrual and collection of all revenues 16 and receipts; and (3) to prescribe such methods of accounting as are neces-17 sary for the performance of the foregoing duties. The payment of 18 any 19 money of the state, or of any money under its control, or the refund of 20 any money paid to the state, except upon audit by the comptroller, shall 21 be void, and may be restrained upon the suit of any taxpayer with the consent of the supreme court in appellate division on notice to the 22 23 attorney-general. In such respect the legislature shall define the

powers and duties and may also assign to him or her: (1) supervision of 1 2 the accounts of any political subdivision of the state; and (2) powers 3 and duties pertaining to or connected with the assessment and taxation 4 of real estate, including determination of ratios which the assessed 5 valuation of taxable real property bears to the full valuation thereof, but not including any of those powers and duties reserved to officers of б a county, city, town or village by virtue of [sections seven and eight 7 of] article nine of this constitution. The legislature shall assign to 8 9 him or her no administrative duties, excepting such as may be incidental 10 the performance of these functions, any other provision of this to constitution to the contrary notwithstanding. 11

12 S 2. Resolved (if the Senate concur), That the foregoing amendment be 13 referred to the first regular legislative session convening after the 14 next succeeding general election of members of the assembly, and, in 15 conformity with section 1 of article 19 of the constitution, be 16 published for 3 months previous to the time of such election.
