AN ACT to amend the tax law, in relation to exempting low-emission and energy efficient vehicles from retail sales and compensating use taxes; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision (a) of section 1115 of the tax law is amended 2 by adding a new paragraph 44 to read as follows:

3 (44) LOW-EMISSION AND ENERGY EFFICIENT VEHICLES. FOR PURPOSES OF A "LOW-EMISSION AND ENERGY EFFICIENT VEHICLE" SHALL MEAN A 5 VEHICLE CERTIFIED BY THE ADMINISTRATOR OF THE UNITED STATES ENVIRON-MENTAL PROTECTION AGENCY PURSUANT TO 23 U.S.C. S 166(F)(3). IF THE 7 ADMINISTRATOR OF THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY HAS 8 SO CERTIFIED ANY VEHICLE AS A LOW-EMISSION AND ENERGY EFFICIENT 9 VEHICLE, THEN, UNTIL SUCH CERTIFICATION OCCURS, "LOW-EMISSION AND ENERGY THAT HAS 10 EFFICIENT VEHICLE" SHALL MEAN ANY VEHICLE ACHIEVED AN POLLUTION SCORE OF NINE OR BETTER AND A GREENHOUSE GAS SCORE OF NINE OR 11 BETTER ON THE GREEN VEHICLE GUIDE MAINTAINED BY THE UNITED STATES 12 13 RONMENTAL PROTECTION AGENCY. THE DEPARTMENT SHALL POST ON ITS WEB SITE A LIST OF LOW-EMISSION AND ENERGY EFFICIENT VEHICLES BY MAKE AND MODEL 14 15 YEAR AND SUCH OTHER SPECIFICATIONS AS MAY BE NECESSARY TO IDENTIFY LOW-EMISSION AND ENERGY EFFICIENT VEHICLE, AND SHALL UPDATE SUCH LIST AS 16 NECESSARY TO PROVIDE A COMPLETE LIST OF LOW-EMISSION AND ENERGY EFFI-17 THE EXEMPTIONS PROVIDED BY THIS SECTION SHALL BE OFFSET 18 CIENT VEHICLES. 19 BY THE PROCEEDS COLLECTED FROM THE AUCTION OF ANY EMISSIONS ALLOWANCES 20 CONTAMINANTS AS PROVIDED FOR IN REGULATIONS ADOPTED BY THE

S 2. This act shall take effect on the first day of the sales tax quarter that begins at least ninety days after the day on which it shall have become a law and shall expire and be deemed repealed December 31, 10 2016.
