AN ACT to amend the environmental conservation law, in relation to environmental quality review of the closure of lands maintained by the office of parks, recreation and historic preservation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 4 of section 8-0105 of the environmental 1 conservation law, as amended by chapter 228 of the laws of 1976, para-2 graph (i) as amended by chapter 252 of the laws of 1977, is amended to 3 4 read as follows:

4. "Actions" include:

6 projects or activities directly undertaken by any agency; or (i) projects or activities supported in whole or part through contracts, 7 grants, subsidies, loans, or other forms of funding assistance from one 8 or more agencies; or projects or activities involving the issuance to a 9 person of a lease, permit, license, certificate or other entitlement for 10 use or permission to act by one or more agencies; 11 12

(ii) policy, regulations, and procedure-making[.]; AND

13 (III) THE CLOSURE OF ACCESS TO THE PUBLIC OF ANY LANDS OWNED OR OPER-ATED BY THE OFFICE 14 OF PARKS, RECREATION AND HISTORIC PRESERVATION. PROVIDED AN APPROPRIATION AND SUCH LABOR AS IS 15 UNLESS THE STATE HAS 16 NECESSARY FOR THE CONTINUOUS MAINTENANCE AND PROTECTION OF SUCH LANDS.

17 S 2. Paragraph (b) of subdivision 2 of section 8-0113 of the environ-18 mental conservation law, as amended by chapter 252 of the laws of 1977, 19 is amended to read as follows:

(b) Criteria for determining whether or not a proposed action may have 20 a significant effect on the environment, taking into account social and 21 22 economic factors to be considered in determining the significance of an 23 environmental effect, PROVIDED, THAT EVERY CLOSURE OF ACCESS ΤO THE 24 PUBLIC OF LANDS OWNED OR OPERATED BY THE OFFICE OF PARKS, RECREATION AND
