AN ACT to amend the county law, in relation to allowing Ontario county to participate in the Foreign Trade Zone program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 224 of the county law is amended by adding a new 2 subdivision 28 to read as follows:
- 28. THE COUNTY OF ONTARIO, THROUGH ITS ONTARIO ECONOMIC DEVELOPMENT CORPORATION MAY MAKE APPLICATION TO THE FOREIGN TRADE ZONES BOARD ESTAB-
- 5 LISHED BY THE ACT OF CONGRESS, APPROVED JUNE EIGHTEENTH, NINETEEN 6 HUNDRED THIRTY-FOUR, ENTITLED "AN ACT TO PROVIDE FOR THE ESTABLISHMENT,
- 7 OPERATION AND MAINTENANCE OF FOREIGN TRADE ZONES IN PORTS OF ENTRY OF 8 THE UNITED STATES, TO EXPEDITE AND ENCOURAGE FOREIGN COMMERCE, AND FOR
- 9 OTHER PURPOSES, " FOR A GRANT TO ONTARIO COUNTY ECONOMIC DEVELOPMENT
- 10 CORPORATION OF THE PRIVILEGE TO HAVE ESTABLISHED, OPERATED AND MAIN-
- 11 TAINED A FOREIGN TRADE ZONE OR ZONES AND FOREIGN TRADE SUB-ZONE OR SUB-
- 12 ZONES WITHIN SUCH COUNTY, AND ADJACENT COUNTIES OF LIVINGSTON, WAYNE, 13 SENECA, YATES AND STEUBEN PURSUANT TO THE PROVISIONS OF SUCH ACT, AND IF
- 13 SENECA, TATES AND STEUBEN PURSUANT TO THE PROVISIONS OF SUCH ACT, AND IF 14 SUCH APPLICATION BE GRANTED, TO HAVE ESTABLISHED, OPERATED AND MAIN-
- 15 TAINED SUCH ZONE OR SUB-ZONE IN ACCORDANCE WITH LAW. THE ONTARIO ECONOM-
- 16 IC DEVELOPMENT CORPORATION MAY ENTER INTO SUCH CONTRACTS AND MAY APPRO-
- 17 PRIATE SUCH SUMS OF MONEY AS IT MAY DEEM PROPER, SUBJECT TO THE
- 18 PROVISIONS OF THIS ARTICLE, TOWARDS THE PROMOTION AND ESTABLISHMENT OF
- 19 SUCH ZONES.
- 20 S 2. This act shall take effect immediately.
