Introduced by M. of A. ORTIZ, McDONOUGH, MALLIOTAKIS -- read once and referred to the Committee on Election Law

AN ACT to amend the military law and the election law, in relation to the counting of ballots of deceased military personnel

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Article 11 of the military law is amended by adding a new
2 section 234 to read as follows:
3 S 234. COUNTING OF BALLOTS OF DECEASED MILITARY PERSONNEL. ANY MEMBER
4 OF THE ARMY, NAVY, AIR FORCE, MARINES, COAST GUARD, ARMY RESERVE, NAVAL
5 RESERVE, MARINE RESERVE, AIR FORCE RESERVE, NATIONAL GUARD, NEW YORK
6 ARMY NATIONAL GUARD, NEW YORK AIR NATIONAL GUARD, NEW YORK GUARD, OR
7 NAVAL MILITIA, WHO CASTS AN ABSENTEE OR MILITARY BALLOT WHILE ON ACTIVE
8 DUTY, SHALL HAVE SUCH BALLOT BE COUNTED NOTWITHSTANDING THE DEATH OF
9 SUCH SERVICE MEMBER, RESULTING FROM INJURIES SUSTAINED WHILE HE OR SHE
10 WAS PRESENT IN A COMBAT THEATER OR COMBAT ZONE OF OPERATIONS, BEFORE THE
11 DATE OF THE SCHEDULED ELECTION FOR WHICH IT WAS CAST.
12 S 2. The election law is amended by adding a new section 8-413 to read
13 as follows:
14 S 8-413. COUNTING OF BALLOTS OF DECEASED MILITARY PERSONNEL. ANY
15 MEMBER OF THE ARMY, NAVY, AIR FORCE, MARINES, COAST GUARD, ARMY RESERVE,
16 NAVAL RESERVE, MARINE RESERVE, AIR FORCE RESERVE, NATIONAL GUARD, NEW
17 YORK ARMY NATIONAL GUARD, NEW YORK AIR NATIONAL GUARD, NEW YORK GUARD,
18 OR NAVAL MILITIA, WHO CASTS AN ABSENTEE OR MILITARY BALLOT WHILE ON
19 ACTIVE DUTY, SHALL HAVE SUCH BALLOT BE COUNTED NOTWITHSTANDING THE DEATH
20 OF SUCH SERVICE MEMBER, RESULTING FROM INJURIES SUSTAINED WHILE HE OR
21 SHE WAS PRESENT IN A COMBAT THEATER OR COMBAT ZONE OF OPERATIONS, BEFORE
22 THE DATE OF THE SCHEDULED ELECTION FOR WHICH IT WAS CAST.
23 S 3. This act shall take effect immediately.
