AN ACT to amend the labor law and the workers' compensation law, in relation to the definition of employment as it concerns professional models and the individuals and entities which engage them; and to repeal certain provisions of the labor law and the workers' compensation law relating thereto

PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-THE BLY, DO ENACT AS FOLLOWS:

Section 1. Subparagraph 3 of paragraph (b) of subdivision 1 of section 1 511 of the labor law is REPEALED.

3 S 2. Subdivision 1 of section 511 of the labor law is amended by adding a new paragraph (c) to read as follows: 4
