AN ACT to amend the emergency tenant protection act of nineteen seventy-four, the emergency housing rent control law and the New York city charter, in relation to investigations and inspections by the city of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision a of section 12 of section 4 of chapter 576 of laws of 1974, constituting the emergency tenant protection act of nineteen seventy-four is amended by adding a new paragraph 9 to read as follows:

- THE STATE DIVISION OF HOUSING AND COMMUNITY RENEWAL MAY AUTHORIZE THE DEPARTMENT OF HOUSING PRESERVATION AND DEVELOPMENT IN THE CITY OF NEW YORK, OR ITS SUCCESSOR AGENCY, TO EXERCISE ANY OF THE DIVISION'S POWERS UNDER THIS ACT WITHIN THE CITY OF NEW YORK, PURSUANT TO AGREEMENT WITH THAT DEPARTMENT OR AGENCY.
- S 2. Subdivision 1 of section 6 of chapter 274 of the constituting the emergency housing rent control law, as amended by chapter 337 of the laws of 1961, is amended to read as follows:
- STATE DIVISION OF HOUSING AND COMMUNITY RENEWAL MAY (A) THE14 AUTHORIZE THE DEPARTMENT OF HOUSING PRESERVATION AND DEVELOPMENT IN CITY OF NEW YORK, OR ITS SUCCESSOR AGENCY, TO EXERCISE ANY OF THE DIVI-SION'S POWERS UNDER THIS LAW WITHIN THE CITY OF NEW YORK, PURSUANT AGREEMENT WITH THAT DEPARTMENT OR AGENCY. 17
- (B) The commission is authorized to make such studies and investi-18 gations, to conduct such hearings, and to obtain such information as the 19 20 commission deems necessary or proper in prescribing any regulation or 21 order under this act or in the administration and enforcement of this 22 act and regulations and orders thereunder.

S 3. Section 1802 of the New York city charter is amended by adding a new subdivision 7 to read as follows:

- ALL POWERS, RIGHTS AND DUTIES AUTHORIZED BY AND PURSUANT TO AN AGREEMENT WITH THE NEW YORK STATE DIVISION OF HOUSING AND OR ITS SUCCESSOR AGENCY, UNDER SECTION TWELVE OF THE EMERGENCY TENANT PROTECTION ACT OF NINETEEN SEVENTY-FOUR AND SUBDIVISION ONE SECTION SIX OF THE EMERGENCY HOUSING RENT CONTROL LAW.
- S 4. Severability. If any provision of this act, or any application of any provision of this act, is held to be invalid, that shall not affect the validity or effectiveness of any other provision of this act, of any other application of any provision of this act or any other provision of any law or code amended by this act.
- This act shall take effect immediately; provided that the amend-14 ments to section 12 of the emergency tenant protection act of nineteen 15 seventy-four made by section one of this act shall expire on the same 16 date as such act expires and shall not affect the expiration of such act as provided in section 17 of chapter 576 of the laws of 17 1974; provided that the amendments to section six of the emergency housing 18 19 rent control law made by section two of this act shall expire on the same date as such law expires and shall not affect the expiration of 20 21 such law as provided in subdivision 2 of section 1 of chapter 274 of the 22 laws of 1946.
