AN ACT to amend the public health law and the mental hygiene law, in relation to directing the commissioner of health and the commissioner of the office for people with developmental disabilities to promulgate rules and regulations requiring every child beginning at the age of eighteen months to be examined for autism spectrum disorders; and to repeal section 2500-j of the public health law relating to screening children for autism spectrum disorders

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 2500-j of the public health law is REPEALED.
2 S 2. The public health law is amended by adding a new section 2500-k
3 to read as follows:
4 S 2500-K. PEDIATRIC WELLNESS VISITS; SCREENING FOR AUTISM SPECTRUM
5 DISORDERS. 1. THE COMMISSIONER SHALL, JOINTLY WITH THE COMMISSIONER OF
6 THE OFFICE FOR PEOPLE WITH DEVELOPMENTAL DISABILITIES, AND ON OR BEFORE
7 MAY FIRST, TWO THOUSAND FIFTEEN, PROMULGATE RULES AND REGULATIONS
8 REQUIRING EVERY PEDIATRIC PRIMARY CARE PROVIDER, CONDUCTING A WELLNESS
9 AND PREVENTATIVE CARE EXAMINATION, ON OR AFTER SEPTEMBER FIRST, TWO
10 THOUSAND FIFTEEN, OF A CHILD EIGHTEEN MONTHS OF AGE OR OLDER, TO SCREEN
11 SUCH CHILD FOR AUTISM SPECTRUM DISORDERS.

1 2. IN ADDITION, SUCH RULES AND REGULATIONS SHALL ESTABLISH GUIDELINES
2 AND PROTOCOLS FOR:

3 (A) THE BEST PRACTICES FOR THE SCREENING FOR AND DIAGNOSIS OF AUTISM
4 SPECTRUM DISORDERS;

5 (B) THE EMPLOYMENT OF OBJECTIVE AUTISM SPECTRUM DISORDER TOOLS; AND

6 (C) THE APPROPRIATE REFERRAL MECHANISM FOR CHILDREN, WHO BASED UPON
7 THE RESULTS OF SCREENING FOR AUTISM SPECTRUM DISORDERS, REQUIRE FURTHER
8 EVALUATION.

9 3. IF THE COMMISSIONER AND THE COMMISSIONER OF THE OFFICE FOR PEOPLE
10 WITH DEVELOPMENTAL DISABILITIES SHALL FAIL TO PROMULGATE, ON OR BEFORE
11 MAY FIRST, TWO THOUSAND FIFTEEN, THE RULES AND REGULATIONS REQUIRED BY
12 SUBDIVISIONS ONE AND TWO OF THIS SECTION, THE DEPARTMENT SHALL ADOPT AND
13 IMPLEMENT THE RELEVANT FEDERAL RULES AND REGULATIONS RELATING THERETO.

14 S 3. The mental hygiene law is amended by adding a new section 16.39
15 to read as follows:

16 S 16.39 PEDIATRIC WELLNESS VISITS; SCREENING FOR AUTISM SPECTRUM DISOR-
17 DERS.

18 THE COMMISSIONER SHALL, JOINTLY WITH THE COMMISSIONER OF HEALTH, AND
19 ON OR BEFORE MAY FIRST, TWO THOUSAND FIFTEEN, PROMULGATE ANY AND ALL
20 RULES AND REGULATIONS REQUIRED BY SUBDIVISIONS ONE AND TWO OF SECTION
21 TWENTY-FIVE HUNDRED-K OF THE PUBLIC HEALTH LAW RELATING TO THE SCREENING
22 OF CHILDREN FOR AUTISM SPECTRUM DISORDERS.

23 S 4. This act shall take effect immediately, except that section one
24 of this act shall take effect September 1, 2015.
