AN ACT to amend the alcoholic beverage control law, in relation to authorizing the imposition of certain terms and conditions as part of certain licenses for on-premises consumption

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 55 of the alcoholic beverage control law is amended by adding a new subdivision 4 to read as follows:

- 4. THE AUTHORITY MAY INCLUDE, AS PART OF A LICENSE UNDER THIS SECTION, TERMS AND CONDITIONS FOR THE PURPOSE OF ASSURING THAT THE LICENSED PREMISES ARE OPERATED IN ACCORDANCE WITH APPLICABLE LAW AND CONSISTENT WITH PUBLIC CONVENIENCE AND ADVANTAGE. PRIOR TO INCLUDING TERMS AND CONDITIONS IN A LICENSE, THE AUTHORITY SHALL CONSULT WITH THE APPLICANT AND ANY PARTY ENTITLED TO RECEIVE NOTICE OF THE APPLICATION. PRIOR TO INCLUDING TERMS AND 16 TIONS IN A LICENSE, THE AUTHORITY SHALL CONSULT WITH THE APPLICANT AND 17 ANY PARTY ENTITLED TO RECEIVE NOTICE OF THE APPLICATION. PRIOR TO INCLUDING TERMS AND CONDI-TIONS IN A LICENSE, THE AUTHORITY SHALL CONSULT WITH THE APPLICANT AND 11 ANY PARTY ENTITLED TO RECEIVE NOTICE OF THE APPLICATION. THE TERMS AND 12 CONDITIONS SHALL BE LEGALLY ENFORCEABLE IN THE SAME MANNER AS APPLICABLE 13 14 PROVISIONS OF THIS CHAPTER OR REGULATIONS OF THE AUTHORITY.
