AN ACT to amend chapter 635 of the laws of 1987, establishing the Oak Brush Plain State Preserve, located on Long Island, in relation to the acquisition of lands previously comprising Pilgrim State Hospital

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Sections 7 and 8 of chapter 635 of the laws of 1987, estab-  
2     lishing the Oak Brush Plain State Preserve, located on Long Island,  
3     section 8 as amended by chapter 209 of the laws of 1989, are amended to  
4     read as follows:  
5     S 7. (A) The commissioner of the office of general services, THE  
6     DORMITORY AUTHORITY OF THE STATE OF NEW YORK OR ANY OTHER SUCCESSOR IN  
7     TITLE shall [arrange for the] transfer to the Oak Brush Plain State  
8     Preserve such lands now OR FORMERLY comprising A PORTION OF THE Pilgrim  
9     State Hospital [now or hereafter not necessary for use by Pilgrim State  
10    Hospital and] where native foliage may reasonably be reestablished.  
11    (B) THE LANDS TO BE TRANSFERRED SHALL BE APPROXIMATELY 118 ACRES, MORE  
12    OR LESS, NOW OR FORMERLY COMPRISING PILGRIM STATE HOSPITAL AND SHALL NOT  
13    INCLUDE ANY LAND PREVIOUSLY TRANSFERRED TO THE POWER AUTHORITY OF THE  
14    STATE OF NEW YORK AND THE LONG ISLAND POWER AUTHORITY AND GENERALLY  
15    DESCRIBED AS FOLLOWS:  
16    ALL THAT PIECE OR PARCEL OF LAND SITUATE IN THE TOWN OF ISLIP, COUNTY  
17    OF SUFFOLK, STATE OF NEW YORK GENERALLY DESCRIBED AS FOLLOWS;  
18    BEGINNING AT A POINT ON THE BOUNDARY LINE BETWEEN THE TOWN OF HUNTING-  
19    TON AND THE TOWN OF ISLIP AT THE NORTHWEST CORNER OF A PARCEL OF LAND  
20    CONVEYED TO LONG ISLAND POWER AUTHORITY SAID POINT ALSO BEING ON THE  
21    EASTERLY BOUNDS OF AN 81.4 ACRE PARCEL OF LAND TRANSFERRED FROM THE  
22    OFFICE OF MENTAL HEALTH TO THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION  
23    ON JANUARY 13, 1999,

1 THENCE FROM SAID POINT OF BEGINNING ALONG THE EASTERLY BOUNDS OF SAID  
2 81.4 ACRE PARCEL OF LAND THE FOLLOWING TWO COURSES AND DISTANCES:

3 1) N.  $0^{\circ} 36' 52''$  W. A DISTANCE OF 156.10 FEET TO A POINT; AND

4 2) N.  $0^{\circ} 59' 13''$  E. A DISTANCE OF 1063.76 FEET TO A POINT;

5 THENCE THROUGH THE LANDS NOW OR FORMERLY OF THE PEOPLE OF THE STATE OF  
6 NEW YORK, PILGRIM PSYCHIATRIC CENTER, THE FOLLOWING 11 COURSES AND  
7 DISTANCES:

8 1) N.  $89^{\circ} 41' 36''$  E. A DISTANCE OF 788.41 FEET TO A POINT;

20 THENCE ALONG SAID SOUTHERLY BOUNDARY THE FOLLOWING TWO COURSES AND  
21 DISTANCES:

22 1) S.  $89^{\circ} 25' 34''$  W. A DISTANCE OF 100.00 FEET TO A POINT; AND

23 2) S.  $89^{\circ} 29' 29''$  W. A DISTANCE OF 2,987.71 FEET TO A POINT;

24 THENCE N.  $0^{\circ} 26' 29''$  E. A DISTANCE OF 486.53 FEET TO A POINT AT THE  
25 SOUTHWEST CORNER OF LANDS CONVEYED TO LONG ISLAND POWER AUTHORITY;

26 THENCE ALONG THE SOUTHERLY, EASTERLY AND NORTHERLY BOUNDS OF SAID  
27 LANDS OF LONG ISLAND POWER AUTHORITY THE FOLLOWING THREE COURSES AND  
28 DISTANCES:

29 1) S.  $89^{\circ} 33' 31''$  E. A DISTANCE OF 287.46 FEET TO A POINT;

30 2) N.  $0^{\circ} 26' 29''$  E. A DISTANCE OF 790.75 FEET TO A POINT; AND

31 3) S.  $67^{\circ} 12' 38''$  W. A DISTANCE OF 312.83 FEET TO A POINT AT THE  
32 NORTHEAST CORNER OF LANDS CONVEYED TO THE POWER AUTHORITY OF THE STATE  
33 OF NEW YORK;

34 THENCE ALONG THE NORTHERLY BOUNDS OF SAID LANDS TO AND ALONG THE EAST-  
35 ERLY AND NORTHERLY BOUNDS OF OTHER LANDS CONVEYED TO LONG ISLAND POWER  
36 AUTHORITY THE FOLLOWING THREE COURSES AND DISTANCES:

37 1) S.  $67^{\circ} 12' 38''$  W. A DISTANCE OF 152.50 FEET TO A POINT;

38 2) N.  $23^{\circ} 53' 06''$  W. A DISTANCE OF 201.65 FEET TO A POINT; AND

39 3) S.  $67^{\circ} 12' 38''$  W. A DISTANCE OF 367.44 FEET TO THE POINT OR PLACE  
40 OF BEGINNING; CONTAINING 117.7 ACRES OF LAND, MORE OR LESS.

41 SUBJECT TO EASEMENT RIGHTS OF OTHERS AS THEY MAY EXIST.

42 EXCEPTING THEREFROM, ALL THAT CERTAIN PLOT, PIECE OR PARCEL OF LAND  
43 SITUATE, LYING AND BEING AT BRENTWOOD, TOWN OF ISLIP, COUNTY OF SUFFOLK  
44 AND STATE OF NEW YORK, BEING BOUNDED AND DESCRIBED AS FOLLOWS:

45 BEGINNING AT A POINT ON THE DIVISION LINE BETWEEN THE PROPERTY NOW OR  
46 FORMERLY OF THE PEOPLE OF THE STATE OF NEW YORK, PILGRIM PSYCHIATRIC  
47 CENTER ON THE NORTH AND LAND NOW OR FORMERLY OF THE LONG ISLAND STATE  
48 PARK COMMISSION SAGTIKOS STATE PARKWAY (MAP 23R-1821, PARCEL IV DATED  
49 JANUARY 20, 1940) ON THE SOUTH, DISTANT 624.61 FEET WESTERLY FROM THE  
50 INTERSECTION OF SAID DIVISION LINE WITH THE WESTERLY SIDE OF SAGTIKOS  
51 PARKWAY, SAID POINT BEING THE NORTHEASTERLY CORNER OF LAND NOW OR  
52 FORMERLY OF TOWN OF ISLIP INDUSTRIAL DEVELOPMENT AGENCY;

53 RUNNING THENCE SOUTH 89 DEGREES 29 MINUTES 29 SECONDS WEST, ALONG LAND  
54 NOW OR FORMERLY OF TOWN OF ISLIP INDUSTRIAL DEVELOPMENT AGENCY 110.00  
55 FEET

56 THENCE NORTH  $00^{\circ} 34' 26''$  WEST, 15.71 FEET;

1       THENCE NORTH 15 DEGREES 48 MINUTES 56 SECONDS EAST, 431.19 FEET;  
2       THENCE SOUTH 45 DEGREES 11 MINUTES 47 SECONDS EAST, 125.75 FEET;  
3       THENCE SOUTH 15 DEGREES 48 MINUTES 56 SECONDS WEST, 354.40 FEET TO THE  
4 NORTHERLY SIDE OF LAND NOW OR FORMERLY OF THE LONG ISLAND STATE PARK  
5 COMMISSION SAGTIKOS STATE PARKWAY (MAP 23R-I821, PARCEL IV DATED JANUARY  
6 20, 1940) AND THE POINT OR PLACE OF BEGINNING.

7       CONTAINING: 44,072 SQUARE FEET OR 1.0117 ACRES OF LAND, MORE OR LESS.

8       (C) THE DESCRIPTION OF THE LANDS TO BE TRANSFERRED PURSUANT TO SUBDI-  
9 VISION (B) OF THIS SECTION IS NOT INTENDED TO BE A LEGAL DESCRIPTION,  
10 BUT IS INTENDED ONLY TO IDENTIFY THE PREMISES TO BE TRANSFERRED. THE  
11 OFFICE OF GENERAL SERVICES MAY PREPARE AN ACCURATE SURVEY AND  
12 DESCRIPTION OF SUCH LANDS WHICH MAY BE USED IN THE TRANSFER THEREOF.

13       (D) THE COMMISSIONER OF THE OFFICE OF GENERAL SERVICES, THE DORMITORY  
14 AUTHORITY OF THE STATE OF NEW YORK OR ANY OTHER SUCCESSOR IN INTEREST AT  
15 THE TIME OF THE TRANSFER OF THE LANDS INTO THE OAK BRUSH PLAIN STATE  
16 PRESERVE SHALL ALSO CONVEY THE EXCEPTED PARCEL OF LAND SPECIFICALLY  
17 DESCRIBED IN SUBDIVISION (B) OF THIS SECTION TO THE TOWN OF ISLIP FOR  
18 STREET OR HIGHWAY PURPOSES FOR THE CONSIDERATION OF ONE DOLLAR;  
19 PROVIDED, HOWEVER, THAT SUCH EXCEPTED PARCEL SHALL REVERT AND BE  
20 CONVEYED TO THE STATE OF NEW YORK FOR INCLUSION IN THE OAK BRUSH PLAIN  
21 STATE PRESERVE IF THE TOWN OF ISLIP SHALL AT ANY TIME CEASE TO USE THE  
22 EXCEPTED PARCEL FOR TOWN STREET OR HIGHWAY PURPOSES.

23       (E) ON OR AFTER THE EFFECTIVE DATE OF THE CHAPTER OF THE LAWS OF 2013  
24 WHICH ADDED THIS SUBDIVISION, THE COMMISSIONER OF THE OFFICE OF GENERAL  
25 SERVICES, THE DORMITORY AUTHORITY OF THE STATE OF NEW YORK OR ANY  
26 SUCCESSOR IN INTEREST SHALL NOT SELL, TRANSFER OR CONVEY ANY OF THE LAND  
27 IN THIS ACT TO A PARTY NOT AUTHORIZED TO HAVE SUCH LANDS SOLD, TRANS-  
28 FERRED OR CONVEYED TO IT PURSUANT TO THIS ACT.

29       S 8. Notwithstanding the provisions of section 45-0113 of the environ-  
30 mental conservation law or any other law, rule or regulation to the  
31 contrary, the lands constituting the Oak Brush Plain State Preserve  
32 shall be acquired by the state nature and historical preserve on January  
33 1, 1991 and shall be dedicated for the purposes of article [forty-five]  
34 45 of such law; PROVIDED, HOWEVER, THAT THE LANDS TRANSFERRED TO THE OAK  
35 BRUSH PLAIN STATE PRESERVE PURSUANT TO SECTION SEVEN OF THIS ACT SHALL  
36 BE ACQUIRED BY THE STATE NATURE AND HISTORICAL PRESERVE ON OR BEFORE  
37 DECEMBER 1, 2013 AND SHALL BE DEDICATED FOR THE PURPOSES OF SUCH ARTICLE  
38 45.

39       S 2. This act shall take effect immediately.
