AN ACT to amend the education law, in relation to enacting the "Commitment to Military Education Act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act shall be known and may be cited as the "Commitment to Military Education Act."

- S 2. The education law is amended by adding a new section 669-e to read as follows:
- S 669-E. TUITION ASSISTANCE FOR MEMBERS OF THE ARMED FORCES OF THE UNITED STATES. 1. ELIGIBLE STUDENTS. STUDENTS MUST BE ENROLLED IN THE STATE OF NEW YORK UNIVERSITY SYSTEM ON THE EFFECTIVE DATE OF THIS SECTION AND MUST HAVE BEEN ENROLLED IN A TUITION ASSISTANCE PROGRAM UNDER A BRANCH OF THE UNITED STATES ARMED FORCES WHICH WAS CANCELLED OR SUSPENDED IN THE YEAR 2013.
- 11 TUITION REDUCTION. NOTWITHSTANDING ANY LAW TO THE CONTRARY, 12 WHO MEET THE REQUIREMENTS OF SUBDIVISION ONE OF THIS SECTION STUDENTS 13 SHALL BE ELIGIBLE FOR REDUCED TUITION IN THE STATE OF NEW YORK UNIVERSI-REDUCED TUITION SHALL BE EOUIVALENT TO THE REGULAR 14 TY SYSTEM. AMOUNT REDUCED BY THE AMOUNT OF ASSISTANCE PER CREDIT HOUR THE STUDENT 15 FORMERLY RECEIVED FROM A TUITION ASSISTANCE PROGRAM UNDER A BRANCH OF 16 17 THE UNITED STATES ARMED FORCES.

3. IMPLEMENTATION. THE STATE UNIVERSITY TRUSTEES AND THE BOARD OF GOVERNORS OF THE COMMUNITY COLLEGE SYSTEM SHALL PRESCRIBE RULES AND REGULATIONS FOR THE IMPLEMENTATION OF THIS SECTION.

- 4. EFFECTIVENESS. STUDENTS SHALL REMAIN ELIGIBLE UNDER THE REQUIRE-MENTS OF SUBDIVISION ONE OF THIS SECTION UNTIL THE TUITION ASSISTANCE PROGRAM UNDER A BRANCH OF THE UNITED STATES ARMED FORCES, WHICH WAS CANCELLED OR SUSPENDED IN THE YEAR 2013, FOR WHICH THEY WERE ENROLLED, OR A SUBSTANTIALLY SIMILAR PROGRAM, IS REINSTATED.
- S 3. This act shall take effect immediately.
