AN ACT to amend the vehicle and traffic law, in relation to establishing a next of kin registry for holders of drivers' licenses, learners' permits and non-driver identification cards

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 215-a to read as follows:

3 S 215-A. NEXT OF KIN REGISTRY. 1. THE COMMISSIONER SHALL ESTABLISH AND OPERATE, WITHIN THE DEPARTMENT, AN AUTOMATED, STATEWIDE INTERNET ACCES-4 SIBLE WEBSITE TO BE KNOWN AS THE "NEXT OF KIN REGISTRY". SUCH REGISTRY 5 6 SHALL BE CAPABLE OF STORING EMERGENCY CONTACT INFORMATION OF THE HOLDERS 7 DRIVERS' LICENSES, LEARNERS' PERMITS AND NON-DRIVER IDENTIFICATION OF 8 CARDS TO BE ACCESSIBLE BY POLICE OFFICERS PURSUANT TO SECTION SIX HUNDRED SIX OF THIS CHAPTER. ANY HOLDER OF A DRIVER'S LICENSE, LEARNER'S 9 PERMIT OR NON-DRIVER IDENTIFICATION CARD MAY VOLUNTARILY SUBMIT, VIA AN 10 INTERNET WEBSITE ESTABLISHED THEREFOR, THE NAMES, ADDRESSES AND TELE-11 PHONE NUMBERS OF TWO EMERGENCY CONTACTS FOR INCLUSION IN THE NEXT OF KIN 12 13 REGISTRY.

2. IN THE IMPLEMENTATION OF THE NEXT OF KIN REGISTRY, THE COMMISSIONER 14 15 SHALL ESTABLISH A PROCESS WHEREBY ANY HOLDER OF A DRIVER'S LICENSE, 16 LEARNER'S PERMIT OR NON-DRIVER IDENTIFICATION CARD MAY ELECTRONICALLY SIGN INTO THE DEPARTMENT INTERNET WEBSITE USING HIS OR HER LICENSE, 17 18 PERMIT OR CARD NUMBER. THEREAFTER, SUCH HOLDER MAY ENTER HIS OR HER EMERGENCY CONTACT INFORMATION FOR NOT MORE THAN TWO EMERGENCY CONTACT 19 PERSONS, OR MAY REVISE OR UPDATE PREVIOUSLY ENTERED EMERGENCY CONTACT 20 21 INFORMATION.

22 3. INFORMATION IN THE NEXT OF KIN REGISTRY SHALL BE MADE AVAILABLE 23 SOLELY FOR THE USE OF POLICE OFFICERS PURSUANT TO SECTION SIX HUNDRED 24 SIX OF THIS CHAPTER. THE INFORMATION IN THE NEXT OF KIN REGISTRY SHALL

1 BE DEEMED TO BE CONFIDENTIAL AND SHALL NOT BE SUBJECT TO DISCLOSURE 2 PURSUANT TO ARTICLE SIX OF THE PUBLIC OFFICERS LAW.

4. FOR THE PURPOSES OF THIS SECTION, "EMERGENCY CONTACT" SHALL MEAN ANY PERSON, EIGHTEEN YEARS OF AGE OR OLDER, DESIGNATED BY THE HOLDER OF A DRIVER'S LICENSE, LEARNER'S PERMIT OR NON-DRIVER IDENTIFICATION CARD TO BE CONTACTED BY A POLICE AGENCY WHEN SUCH HOLDER IS RENDERED UNABLE 7 TO COMMUNICATE DUE TO PHYSICAL INJURY, DEATH OR INCAPACITATION.

8 S 2. The vehicle and traffic law is amended by adding a new section 9 606 to read as follows:

10 S 606. NOTIFICATION OF EMERGENCY CONTACTS. WHEN A MOTOR VEHICLE ACCI-OR ANY OTHER EVENT RESULTS IN PHYSICAL INJURY, DEATH OR INCAPACI-11 DENT TATION OF ANY PERSON, THE POLICE OFFICER INVESTIGATING SUCH ACCIDENT 12 OR EVENT SHALL ATTEMPT TO LOCATE AN EMERGENCY CONTACT OF THE INJURED PERSON 13 14 FROM THE NEXT OF KIN REGISTRY ESTABLISHED PURSUANT TO SECTION TWO 15 HUNDRED FIFTEEN-A OF THIS CHAPTER. A POLICE OFFICER SHALL, WHEN PRACTI-16 CABLE, EXPEDITIOUSLY NOTIFY AN EMERGENCY CONTACT OF EACH SUCH INJURED 17 PERSON AND INFORM THE EMERGENCY CONTACT OF THE HOSPITAL OR OTHER LOCATION AT WHICH THE INJURED PERSON HAS BEEN TAKEN. 18

19 S 3. This act shall take effect on the one hundred eightieth day after 20 it shall have become a law; provided, that, effective immediately, any 21 actions necessary to implement the provisions of this act on its effec-22 tive date are authorized and directed to be completed on or before such 23 date.
