Introduced by M. of A. GUNTHER -- read once and referred to the Committee on Ways and Means

AN ACT to authorize the city of Middletown to enter into a contract to sell or pledge as collateral for a loan some or all of the delinquent liens held by such city to a private party or engage a private party to collect some or all of the delinquent tax liens held by it

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Notwithstanding any provision of any general, special or
2 local law to the contrary, the city of Middletown may enter into a
3 contract to sell some or all of the delinquent tax liens held by it to a
4 private party, subject to the following conditions:
5 (a) The consideration to be paid for a sale of the delinquent tax
6 liens held by it may be more or less than the face amount of the tax
7 liens sold.
8 (b) Property owners shall be given at least 30 days advance notice of
9 sale in the same form and manner as is provided by subdivision 2 of
10 section 1190 of the real property tax law. Failure to provide such
11 notice or the failure of the addressee to receive the same shall not in
12 any way affect the validity of any sale of a tax lien or tax liens or
13 the validity of the taxes or interest prescribed by law with respect
14 thereto.
15 (c) The city of Middletown shall set the terms and conditions of the
16 contract of sale or loan.
17 (d) The tax lien purchaser must 30 days prior to the commencement of
18 any foreclosure action provide to the city of Middletown a list of liens
19 to be foreclosed. The city of Middletown may, at its sole option and
20 discretion, repurchase a lien or liens on the foreclosure list from the
21 tax lien purchaser. The repurchase price shall be the amount of the lien
22 or liens plus any accrued interest and collection fees incurred by the
23 tax lien purchaser through the date of repurchase. The tax lien purchas-

1 er shall provide the foreclosure list to the city of Middletown, along
2 with the applicable repurchase price of each lien, by certified mail,
3 and the city of Middletown shall have 30 days from receipt to notify the
4 tax lien purchaser of its option to purchase one or more of the liens.
5 If the city of Middletown opts to purchase the lien, it shall provide
6 payment within 30 days of receipt of the repurchase price of said lien
7 or liens. If the city of Middletown shall fail to repurchase the lien or
8 liens the tax lien purchaser shall have the right to commence a foreclo-
9 sure action immediately upon notice from the city of Middletown of its
10 refusal or at the expiration of the 30 day review period whichever
11 occurs first.

12 (e) The sale of a tax lien pursuant to this act shall not operate to
13 shorten the otherwise applicable redemption period or change the other-
14 wise applicable interest rate.

15 (f) Upon the expiration of the redemption period prescribed by law,
16 the purchaser of a delinquent tax lien, or its successors or assigns,
17 may foreclose the lien as in an action to foreclose a mortgage as
18 provided in section 1194 of the real property tax law. The procedure in
19 such action shall be the procedure prescribed by article 13 of the real
20 property actions and proceedings law for the foreclosure of mortgages.
21 At any time following the commencement of an action to foreclose a lien,
22 the amount required to redeem the lien, or the amount received upon sale
23 of a property, shall include reasonable and necessary collection costs,
24 attorneys' fees, legal costs, allowances, and disbursements.

25 (g) The provisions of title 5 of article 11 of the real property tax
26 law shall apply so far as is practicable to a contract for the sale of
27 tax liens pursuant to this act.

28 S 2. Notwithstanding any provision of any general, special or local
29 law to the contrary, the city of Middletown may enter into a contract to
30 pledge as collateral for a loan some or all of the delinquent tax liens
31 held by it to a third party or engage a third party to collect some or
32 all of the delinquent tax liens held by it subject to the following
33 conditions:

34 (a) Any loan provided under this section shall bear an interest rate
35 to be determined by the city of Middletown.

36 (b) Any contract for the collection of delinquent tax liens the fee
37 paid by the city of Middletown shall not exceed 10% of the outstanding
38 balance of the tax lien being collected and said fee shall be borne by
39 the delinquent taxpayer.

40 S 3. This act shall take effect immediately.
