AN ACT to amend the agriculture and markets law, in relation to requiring certain animal shelters to prepare annual reports on the number of animal intakes and dispositions

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The agriculture and markets law is amended by adding a 2 section 374-a to read as follows:
- 3 SHELTER ANNUAL REPORTS. 1. ANY ANIMAL SHELTER THAT 374-A. ANIMAL 4 RECEIVES STATE FUNDING SHALL, BY JANUARY FIRST OF EACH YEAR, PREPARE 5 ANNUAL REPORT DISCLOSING:
- 6 (A) THE NUMBER OF ANIMAL INTAKES, INCLUDING, BUT NOT LIMITED TO 7 ANIMALS THAT WERE:
 - (I) SURRENDERED BY OWNERS;
 - (II) BROUGHT IN BY ANIMAL CONTROL, SPECIFIED BY JURISDICTION; AND
- (III) STRAYS TAKEN IN BY SOMEONE OTHER THAN THE OWNER; 10
- 11 (B) THE NUMBER OF ANIMAL DISPOSITIONS, INCLUDING, BUT NOT LIMITED TO 12 ANIMALS THAT:
- (I) WERE ADOPTED; 13
- 14 (II) WERE RELEASED TO OWNERS;
- (III) WERE TRANSFERRED TO OTHER FACILITIES, SPECIFIED BY FACILITY; AND 15
- (IV) DIED, SPECIFYING THE REASON FOR DEATH, INCLUDING, BUT NOT LIMITED 16
- TO NATURAL CAUSES OR EUTHANASIA, AND SPECIFYING THE REASON FOR SUCH 17
- 18 EUTHANASIA.
